Financial report: Dir. Whitington discussed the financial statement (10-month period ending 4/30/09). She explained the \$3600 deposit was the ongoing funding provided by SAWA for the new office that we are sharing with them. She corrected the "Trout United "to "Trout Unlimited" and that it should be placed in the General Funds, not restricted. This deposit was from her contracted work for them on behalf of the EMARCD. She added the newly hired manager will be able to help with the financial presentation.
