Ellen,

On page 28 of the audit there are two findings from the auditors. Item #2 was addressed since we don't have any furniture etc. It was all liquidated just after the completion of our year end and if you need a list we can get you one. There is no office or anything which would involve insurance.

Item number one was addressed and the files rebuilt. If you go to our website and look on any of the agenda board packets you will now see a breakdown of Developer Deposits in our QuickBooks accounting program. So now every developer's funds and every project going forward will have it's own GL with appropriate expenses applied to their specific project and reports done.

As I also mentioned to you, we have finally gotten approval from the Board of Supervisors to do a compilation of our accounting every year to be submitted to the state with an Audit done every third year of just the third year. In the interim we are also required to forward a quarterly report to our County Auditor along with the year end compilation at the end of June. Our Board feels that now we have enough controls and checks and balances on the accounting part of our operation and better technology in order for us to provide the County, the state and the public with a clear picture of accounting for all the activities of our District.



Opportunity to Engage in State Mandates Working Group

Does somebody at your district handle state mandate reimbursement claims? If so, they may be interested in joining the Local Government Mandated Services Working Group. The group regularly meets to review and discuss items related to securing payment for state mandated programs and services for special districts, counties, and cities.

At the first meeting of 2017 participants received updates on the National Association of Counties (NACo) Letter on Unfunded Federal Mandates to U.S. House Committee on Oversight and Government Reform; Assembly Bill 216, which would require prepaid postage on vote by mail ballots; and a recent Sexually Violent Predator mandate ruling on the state's renewed obligation to pay between \$20 million to \$25 million to counties annually. The working group typically meets the day before the Commission on State Mandates hearings to discuss what's on the Commission's agenda, current legislation that may contain mandates, current and past litigation related to mandates and their implications, as well as anticipated future test claims. One of the promises President Donald Trump made during his campaign was to overhaul the EPA's Waters of the U.S. (WOTUS) rule. Today, Trump signed an executive order directing the EPA and the Army Corps of Engineers to begin revamping the rule, which is currently on hold due to pending lawsuits.

The executive order instructs both agencies to ensure the rule promotes economic growth and minimizes regulatory uncertainty, and according to the president, begins "paving the way for (its) elimination." To read

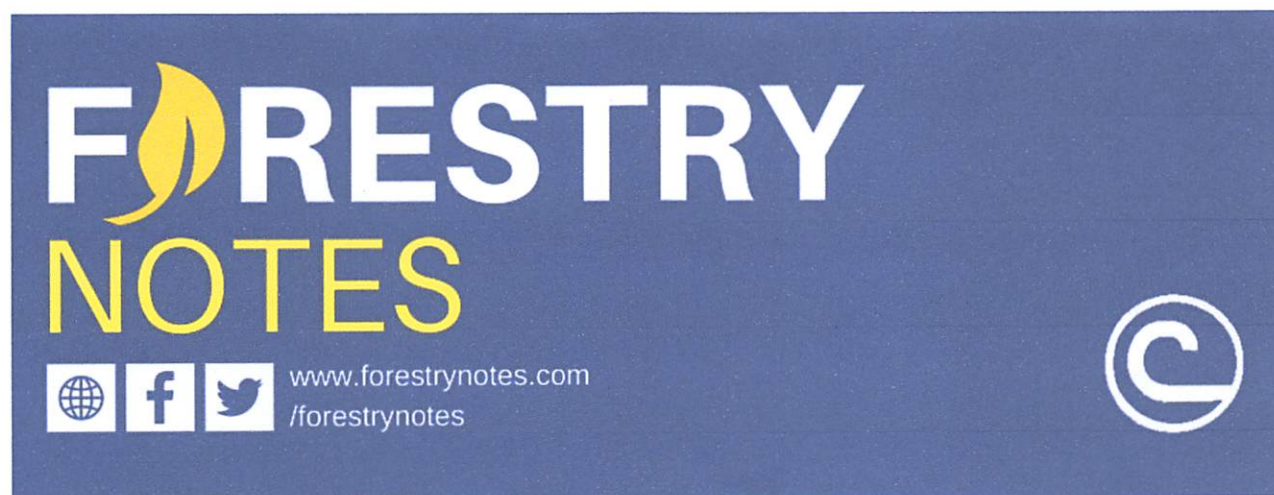

Heck took part in a plenary session with the U.S. Forest Service, Natural Resources Conservation Service, state wildlife agencies, American Forest Foundation, Hunting Heritage, and Wildlife Management Institute. The conference agenda covered a wide array of topics, including State Forest Action Plans, leveraging partnerships, threatened and endangered species, and prescribed fire.

date. The Commissioner suggested districts should be required to hold an election every 10 years to reauthorize their existence.

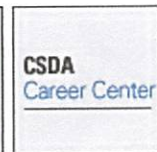

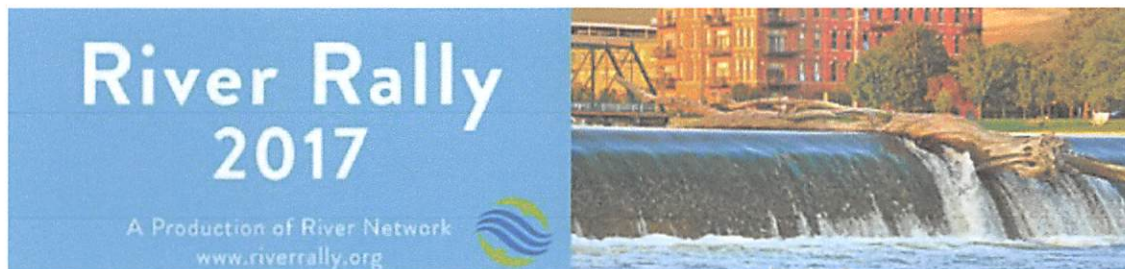

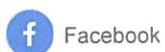

RE: Property/Liability Longevity Distribution

Dear Ms. Corona,

On February 2, 2017, the SDRMA Board of Directors approved a longevity distribution for the eighth year in a row. The Longevity Distribution Policy was adopted by the Board to recognize and reward members for their loyalty and commitment to SDRMA programs. The policy is consistent with the goals and objectives of the Board's strategic business plan and helps ensure pool stability by rewarding members for remaining in our Property/Liability and Workers' Compensation programs.

This year, the Board approved a longevity distribution in the amount of \$247,965 for Property/Liability members and \$463,920 for Workers' Compensation members. For the Property/Liability program, over 91% of members will receive the distribution credit and for the Workers' Compensation program, over 90% of members will receive the distribution credit.


Congratulations! Since you have participated in our Property/Liability Program for 15 years as of June 30, 2016, your agency will receive a longevity distribution credit on your 2017-18 renewal invoice in the amount of \$22. We encourage you to share this valuable news with your governing body!

There is no action required by your agency. Every member that has completed the 3 full program year initial commitment period for the Property/Liability program is eligible to receive a longevity distribution credit when they renew coverage. The longevity distribution may be declared by the Board of Directors each year only after all Board policy reserve requirements have been met. The amount available for the longevity distribution is the amount of investment earnings on reserves above the Board approved confidence level for each program as of June 30. The distribution is weighted based on the member's length of time in that program and the amount of the member's annual contributions compared to the total contributions of all pool members.

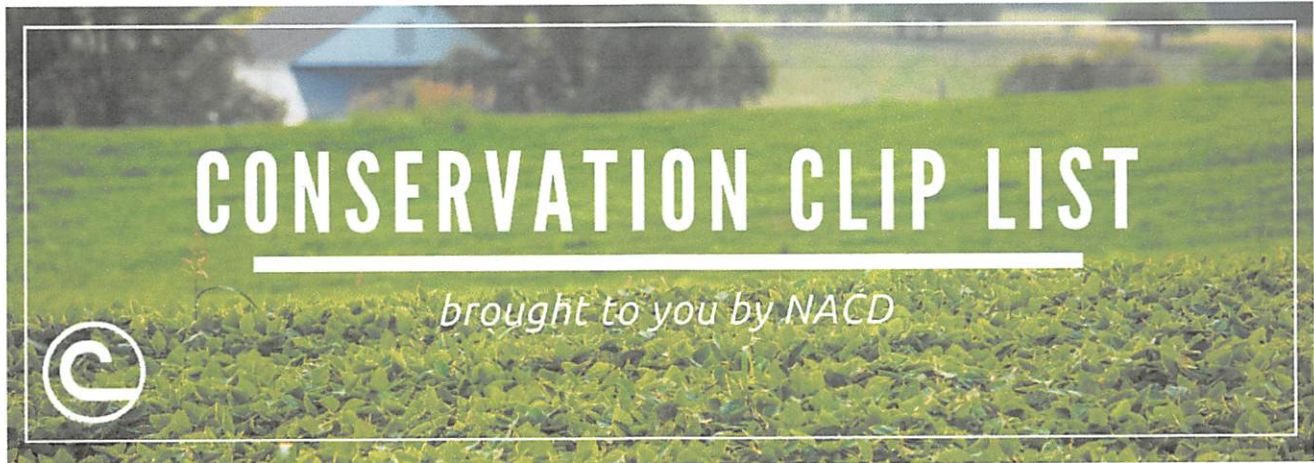

Wednesday's Senate hearing was focused on "modernizing" the current act by making it more challenging to list a new species, for example, or expediting the removal of species that are already listed.

Lead Ammunition Poisons Wildlife But Too Expensive To Change, Hunters Say via NPR

On the day before President Trump's inauguration, the outgoing Obama administration passed a last-minute directive banning the use of lead ammunition and fishing sinkers on federal land. But hunters are hoping Trump will soon overturn it.

FFAR announces \$10 million Pollinator Health Fund via Agri-Pulse

The Foundation for Food and Agriculture Research is committing \$10 million toward reversing the decline of the pollinator population in the U.S. The Pollinator Health Fund will support research and technology developments that affect pollinators in agricultural landscapes and real-world applications to beekeeping, land management, and farming practices.

Supporters applaud proposed noxious weed program via Missoulian

A bill that could pump more than \$2 million annually into the fight against noxious weeds in wildlife habitat drew unanimous support from weed managers, wildlife managers, and conservation and livestock groups. House Bill 434, known as the Montana Wildlife Habitat Improvement Act, creates a new grant program and advisory council administered by Montana Fish, Wildlife and Parks.

Floods In San Jose Push 14,000 People Out Of Their Homes via NPR

Flooding in San Jose, Calif., has prompted the evacuation of at least 14,000 residents. Flooding along Coyote Creek came after a series of heavy rainstorms combined with water rushing down the spillway of nearby Anderson Reservoir, which is now filled to capacity. Now floodwaters are receding, but the danger isn't over. In addition to the 14,000 mandatory evacuations, some 22,000 people were encouraged to leave their homes.

Kevin's Corner

Did we or did we not?

Just this past month a letter was sent to both houses of the State Legislature advising the legislators that the Riverside County Board of Supervisors SUPPORTS Senate Bill-1 (and Assembly Bill-1). Both of these identical bills call for very large tax and fee increases (\$5.5 billion) to be levied against private and commercial vehicle owners (and fuel) in California, with the hardest hit likely to be individuals who commute long distances to work—like many of the residents in Western Riverside County. The problem with the letter of support was that SB-1 & AB-1 never came before the Board of Supervisors for a vote. So how did a SUPPORT letter obtain the green light to be sent? Seems that back in May 2015 a similar Transportation Bill was considered by the Board for support and passed on a 3-2 vote (with Supervisor Washington and I voting no). Somehow, that old vote was the justification to support all the new fees and taxes. Never mind that it was a different bill in a different legislative session and that one of the 2015 supporters on the Board of Supervisors tragically passed away in late 2016 - somehow somehow a letter was still issued on behalf of the current Board. At the March 7th Board meeting, I will be proposing a new Board policy to prevent future misrepresentations of the full Board.

Helping The Homeless Gets Complicated.

Nearly every community in Riverside County has had ongoing concerns with the homeless. While we have had great success housing veterans and families with children, a segment of the homeless have absolutely no desire to be placed in a shelter (even if we had the room for all of them), and a large segment truly need serious treatment for mental health and/or addictions. With few communities (if any) willing to allow new treatment or housing facilities to be located within their boundaries, the problems and challenges continue, with the homeless only being shuffled around by code or law enforcement. A regional task force of sorts has been working together for some time now, trying to get everybody to row the same direction. Our office has been helping lead the charge, along with several cities and mayors. Stay tuned, maybe just maybe some new ideas and commitments will come together and we can implement a more comprehensive strategy to both help the homeless and to protect our neighborhoods and downtown areas.

What's next for Marijuana Advocates?

Last month I shared that the Board of Supervisors will be holding a workshop on the voter approved legalization of Recreational Marijuana. That hearing will be in the afternoon of March 21st here at the County Administrative Center in Downtown Riverside (you can also watch live or later online from the comfort of your office or home). Recent comments from the Federal Department of Justice have implied that the Feds might crack down on Recreational Marijuana in states like California that have legalized it. This could put counties and cities who move to license and regulate growing, processing, or selling marijuana according to state law in the crosshairs of the Department of Justice for violating federal law, further complicating an already complicated issue. Once again-- Stay tuned!

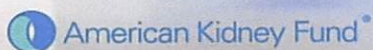


1st District Planning Commissioner Taking Leadership Role at County TLMA

Summary

There is a growing awareness that the task of conserving nature will not be simple and that it will require non-traditional tools that can deal with the inherently complex behavior of natural systems. The methodology known as "Structural Equation Modeling" or SEM represents a framework for studying complex relationships in systems. In this talk I will provide simple illustrations of the methodology, emphasizing its value for conservation biology. I will also provide an overview of the ongoing growth in capability of the methodology and its relationship to other methods of analysis.



James B. Grace obtained his B.S. from Presbyterian College, his M.S. from Clemson University, and his Ph.D. from Michigan State University. He served on the faculty at the University of Arkansas for five years and then later became a Professor of Botany at Louisiana State University. He is currently a Senior Scientist with the US Geological Survey in Lafayette Louisiana and holds an Adjunct Professorship in Biology at the University of Louisiana. In 2000, he was the recipient of the Meritorious Research Award by the Society

of Wetland Scientists and in 2003 he received the National Science Excellence Award from the U.S. Geological Survey. He was selected to be a Fellow of the Ecological Society of America and promoted to the Senior Scientist ranks in 2014. He has published over 180 papers and reports, including 3 books, one on competitive interactions, one on community analysis, and one on structural equation modeling.
