

Planting early-season milkweeds, such as California milkweed, is not a silver bullet that will single-handedly help save the western monarch, but it is an important tool in the restoration toolkit that might make a significant difference. # **USDA's Coronavirus Food Assistance Program for Producers**

As part of the White House's April 17 announcement of a \$19 billion Coronavirus Farm Assistance Program (CFAP), USDA will provide \$16 billion in direct support based on losses for agricultural producers where prices and market supply chains have been impacted. CFAP will provide assistance to most farms that have experienced at least a five percent loss and will be available to farms regardless of size. USDA is still finalizing details on the actual payment rates. Once the rule making process is complete, the application period will be open. As part of applying for the program, producers will need to contact the Farm Service Agency county office to schedule an appointment. USDA is advising producers to prepare for the application now. # CNRA & Cal-EPA's Environmental Engagement Conference

The California Natural Resources Agency and the California Environmental Protection Agency have teamed up to offer three days of webinars, June 2 - 4, about online environmental engagement during the COVID-19 crisis. The conference, "Online Environmental Engagement: Building Our Skills Together" brings together community leaders, government agencies, and experts in the field of public engagement to share tips and learn from each other. There is no cost to attend. Sessions will cover: (1) using digital engagement tools to plan and participate in online meetings, (2) how organizations are adapting engagement practices during the COVID-19 crisis, and (3) what it all means for equity and environmental justice. # San Mateo RCD's Butano Creek Project Featured by NOAA

The National Oceanic and Atmospheric Administration featured the San Mateo RCD's work on Butano Creek in their nationally distributed newsletter. In 2017, the NOAA Restoration Center awarded the San Mateo RCD more than \$1.4 million through the NOAA Coastal Resilience Grants Program to support restoration work in Butano Creek. San Mateo County and the California Department of Parks and Recreation provided additional funding and support. In October 2019, the RCD finished the effort to remove the sediment and restore the creek, which will reduce flooding and open up 10 miles of habitat historically used for spawning, rearing, and refuge for steelhead and coho salmon. # Conservation Innovation Grants Program Funds a Market-Based Tool for Groundwater Conservation

Through a Conservation Innovation Grant from the Natural Resources Conservation Service, The Nature Conservancy provided essential support for Fox Canyon Groundwater Management Agency and project partner California Lutheran University in their effort to establish a market-driven and producer-led approach to reduce groundwater pumping. Under a cap-and-trade style system, agricultural producers in the Fox Canyon area have fixed groundwater allocations based on historical use and can then purchase or sell their unused allocation and realize income from their water savings. The Department of Conservation's FY 2019-2020 Sustainable Agricultural Lands Conservation Program (SALC) grant application period is now open. The program invests in agricultural land conservation with revenue from the California Climate Investments Fund, made available for projects that reduce greenhouse gas emissions while providing additional benefits to California communities. CAL FIRE's California Forest Stewardship Program will fund technical and financial assistance to forestland owners. Projects may include forest restoration activities for forestland already impacted by natural disturbance such as fire, insect, and disease, and forest management practices that promote forest resilience to severe wildfire, climate change, and other disturbances. CAL FIRE expects to award at least \$2.2M of Proposition 68 funding for Forestry Assistance in the fiscal year 2019/2020 with a minimum grant amount of \$750,000. Projects must involve only long-term protection, restoration, enhancement and/or establishment of wetland and associated upland habitats to benefit migratory birds. Resource Conservation Districts are eligible. The grant coordinator Stacy Sanchez recommends the U.S. Small (max request \$100,000) to learn the process before applying for the more tedious U.S. Standard (\$1,000,000) grant program. Stacy says "I also recommend contacting the Migratory Bird Joint Venture in your area. They will be a key tool for developing partnerships and providing advice for your project. They also providing rankings on projects in their Joint Venture area for recommendations to the North American Wetlands Conservation Council to benefit your score." Applications are due July 10. # **DOC Riparian Corridor Restoration and Conservation Grants (July 15)**

The Department of Conservation's Riparian Corridor Restoration and Conservation Grants Solicitation and Grant Agreement is now final. \$8,500,000 in bond funding is available **solely for Resource Conservation Districts** through this solicitation for watershed restoration projects and conservation projects on agricultural lands. - b) Create friendly awareness of who is applying to which grants
- c) Brainstorm and identify projects for future collaborative funding

This 2016 Natural Resources Defense Council article delves into the history of environmental justice in the US which segues neatly into this 2018 Washington Post article that examines the impact of specific federal policies. If you're keen to see how this plays out in California, particularly in agricultural contexts, check out the global Environmental Justice Atlas and zoom into California. You can also learn about current statewide issues through the California Environmental Justice Alliance, with member groups across the state.

<u>Environmental Justice Network</u> or the East Bay's <u>Asian Pacific Environmental Network</u>. It's a safe bet that your District has an EJ group based there or that covers your area! 

#### Bi-Weekly COVID-19 District Manager Calls

CARCD has been hosting COVID-19 discussion calls for District Managers/Executive Directors to share stories and best practices. The recurring call is every other Monday at 9am and is open to members and non-members. #### **USDA's Coronavirus Food Assistance Program for Producers**

As part of the White House's April 17 announcement of a \$19 billion Coronavirus Farm Assistance Program (CFAP), USDA will provide \$16 billion in direct support based on losses for agricultural producers where prices and market supply chains have been impacted. CFAP will provide assistance to most farms that have experienced at least a five percent loss and will be available to farms regardless of size. USDA is still finalizing details on the actual payment rates. Once the rule making process is complete, the application period will be open. As part of applying for the program, producers will need to contact the Farm Service Agency county office to schedule an appointment. USDA is advising producers to prepare for the application now. #### **CNRA & Cal-EPA's Environmental Engagement Conference**

The California Natural Resources Agency and the California Environmental Protection Agency have teamed up to offer three days of webinars, June 2 - 4, about online environmental engagement during the COVID-19 crisis. The conference, "Online Environmental Engagement: Building Our Skills Together" brings together community leaders, government agencies, and experts in the field of public engagement to share tips and learn from each other. There is no cost to attend. Sessions will cover: (1) using digital engagement tools to plan and participate in online meetings, (2) how organizations are adapting engagement practices during the COVID-19 crisis, and (3) what it all means for equity and environmental justice. In light of the potential impact on RCDs from the requirements of the Coronavirus Aid, Relief, and Economic Security (CARES) Act and not being included as recipients of the benefits, we need to let our elected officials know about how RCDs are different from other public agencies! CARCD and our legislative lobbyists Pacific Policy Group are doing this at the State Capitol, however there is so much going on, it's hard to hold the attention of the members for long. We need you to reach out to either the local staff in the assembly and senate offices or their capitol offices.

<u>The talking points are available here</u>. While CARCD has lobbied the State to include RCDs in the federal CARES Act relief funding, this is an opportunity to raise the issue broadly of RCDs needing more stable sources of funding.

#### **CDFA Awards \$22M in Grants**

The CDFA has selected 316 Healthy Soils Program (HSP) Incentives Program projects for grant awards totaling approximately \$22.06 million. The program encourages farmers and ranchers to implement on-farm practices that improve soil health, reduce greenhouse gas emissions and sequester carbon in soils. The 2020 HSP Incentives Program funding cycle was the first time applications were accepted on a rolling basis, with a final deadline of June 26 or until funds were expended, whichever came first. # **FEMA Fire Prevention and Safety Grants (May 29)**

The Federal Emergency Management Agency's Fire Prevention and Safety Grants fund fire prevention and safety activities, including community and wildfire risk reduction. # DOC Sustainable Agricultural Lands Conservation Program (May 29)

The Department of Conservation's FY 2019-2020 Sustainable Agricultural Lands Conservation Program (SALC) grant application period is now open. The program invests in agricultural land conservation with revenue from the California Climate Investments Fund, made available for projects that reduce greenhouse gas emissions while providing additional benefits to California communities. The Acquisition Grant pre-proposals deadline has been extended until May 29, 2020. Planning Grant pre-proposal deadline (optional) remains Wednesday, July 1. SALC staff will host a Pre-proposal Technical Assistance Workshop this spring to provide an overview of SALC, discuss recent changes, and provide assistance on preparing the pre-proposal. ### **CAL FIRE Forestry Assistance Grant Opportunity (May 31)**

CAL FIRE's California Forest Stewardship Program will fund technical and financial assistance to forestland owners. Projects may include forest restoration activities for forestland already impacted by natural disturbance such as fire, insect, and disease, and forest management practices that promote forest resilience to severe wildfire, climate change, and other disturbances. CAL FIRE expects to award at least \$2.2M of Proposition 68 funding for Forestry Assistance in the fiscal year 2019/2020 with a minimum grant amount of \$750,000. #### **NACD Technical Assistance Grants (June 1)**

The USDA Natural Resources Conservation Service has entered into an agreement with the National Association of Conservation Districts to provide funding to enhance conservation district technical assistance across the nation through the NACD Technical Assistance Grants. \$1,350,000 will be allocated as grants to hire local district/state agency/state association/RC&D/tribal employees to assist landowners in implementing Conservation Stewardship Program contracts. \$5,150,000 will be allocated as grants to hire local district/state agency/state association/RC&D/tribal employees to provide conservation operations planning assistance. # EPA's Supporting Anaerobic Digestion in Communities (June 2) \*\*NEW\*\*

The EPA's Office of Land and Emergency Management has announced the opening of their Supporting Anaerobic Digestion in Communities grant. The goal is to help reduce food loss and waste and divert food waste from landfills by expanding anaerobic digester capacity. Applications must address one or more of the following objectives:

- Support state, tribal and/or local government programs that seek to use AD to increase their
  organic waste diversion rates or support other sustainability goals;
- demonstrate and/or implement solutions and/or approaches for increasing AD utilization that can be replicated by other communities or governments; or

Resource conservation districts jump into action to help save the monarch butterfly



The recent staggering decline of the population of the western monarch butterfly to just 1% of its levels 20 years ago has prompted resource conservation districts (RCDs) throughout the state into action. RCDs are working on a multi-pronged approach to help save this iconic species, including improving management of coastal overwintering sites and creating breeding and migratory habitat. RCDs are developing new monarch conservation programs while also integrating monarch conservation practices into their existing programs. RCDs are also engaged in education and outreach to help raise awareness about the status of the monarch and encourage farmers, ranchers, and homeowners to take part in the species' recovery.

In 2019, the California Association of Resource Conservation Districts (CARCD) was awarded a monarch block grant from the Wildlife Conservation Board. Through this funding source, CARCD was able to fund 13 RCD-led projects distributed throughout the state, bringing over \$700,000 to local economies to enhance pollinator habitat and bring back the monarchs. Many RCDs have already started project implementation: Yolo County RCD, Alameda County RCD, Gold Ridge RCD, RCD of Greater San Diego County, and Solano RCD.

Ventura County provides a wealth of opportunities for monarch conservation. The region contains both coastal overwintering sites as well as inland locations that are prime areas for breeding and nectar habitat restoration. The Ventura County Resource Conservation District is developing a multi-faceted approach to monarch conservation, which includes enhancing monarch overwintering sites, integrating pollinator habitat into their firewise demonstration garden, and creating a regional technical advisory working group to address current and future conservation and funding efforts.

# WCB Wildlife Corridor and Fish Passage Projects (June 11)

The Department of the Interior Fish and Wildlife Service's U.S. Standard Grants Program is a competitive, matching grants program that supports public-private partnerships carrying out projects in the United States that further the goals of the North American Wetlands Conservation Act. Projects must involve only long-term protection, restoration, enhancement and/or establishment of wetland and associated upland habitats to benefit migratory birds. Resource Conservation Districts are eligible. The grant coordinator Stacy Sanchez recommends the U.S. Small (max request \$100,000) to learn the process before applying for the more tedious U.S. Standard (\$1,000,000) grant program. Stacy says "I also recommend contacting the Migratory Bird Joint Venture in your area. They will be a key tool for developing partnerships and providing advice for your project. They also providing rankings on projects in their Joint Venture area for recommendations to the North American Wetlands Conservation Council to benefit your score." Applications are due July 10. # **DOC Riparian Corridor Restoration and Conservation Grants (July 15)**

The Department of Conservation's Riparian Corridor Restoration and Conservation Grants Solicitation and Grant Agreement is now final. \$8,500,000 in bond funding is available **solely for Resource Conservation Districts** through this solicitation for watershed restoration projects and conservation projects on agricultural lands. Eligible projects include riparian corridor, oak woodland, native grassland, and aspen forest restoration and enhancement on California's farm and ranch lands. 





#### Latest Congressional Legislation Addresses Local **Governments' COVID-19 Relief Needs**

The U.S. House of Representatives made history last Friday, passing a \$3 trillion emergency appropriations bill responding to COVID-19 and changing the Rules of the House to allow proxy voting. The Health and Economic Recovery Omnibus Emergency Solutions (HEROES) Act contains another \$3 trillion proposed for

COVID-19 response. The bill will go to the U.S. Senate, where it will receive significant scrutiny.

The bill favorably includes two primary federal priorities for special districts that CSDA has been pushing for: expanding payroll tax credits for providing emergency leave and access to capital. Unfortunately, the bill does not favorably address special districts' access to fiscal relief funds, and CSDA is working with a coalition of national and congressional partners to address this issue. 





# Household Hazardous Waste Collection in Riverside County to Resume June 1

Residents will once again be able to safely dispose of household hazardous waste items such as motor oil, paints, and batteries at collection facilities located throughout Riverside County.



In an effort to help prevent pollution and damage to local watersheds, the Riverside County Department of Waste Resources will be resuming operation of its Household Hazardous Waste (HHW) collection facilities on Monday, June 1.

The disposal of HHW is critical to watershed protection. When HHW is thrown away improperly, pollutants can get into storm drains and stream right into local watersheds. Materials such as motor oil and oil filters, anti-freeze, paints, solvents, cleaners and old batteries should always be taken to a certified collection facility.

HHW facilities have been closed and drop-off events have been suspended since March 17 to help reduce the spread of COVID-19. It was determined that maintaining these facilities and events would have created risks to the public and employees, as it would have been difficult to maintain proper social distancing measures and there was a shortage of necessary personal protective equipment. As the County of Riverside has moved forward in the reopening of several categories of businesses, the determination has been made that it is now safe to reopen HHW facilities.

In light of the ongoing COVID-19 situation, several precautions will be taken at HHW facilities, including having customers stay in their vehicle at all times, requiring mandatory use of face coverings, and requiring that materials be kept in an unlocked trunk or bed of vehicle for easy retrieval by staff.

For members of the public who prefer to avoid public spaces at this time, there are several easy and safe measures to temporarily store HHW materials at home until they are ready to be dropped off:

- Store HHW out of reach of children in closed containers
- Keep HHW in their original containers
- Do not mix HHW products
- Never throw HHW into the garbage or on the ground
- Never pour HHW in the toilet or sinks or down the storm drain.

# NACD COMMENTS ON RCPP RULE

Last week, NACD submitted public comments to the Natural Resources Conservation Service (NRCS) on the interim Regional Conservation Partnership Program (RCPP) rule.

RCPP was first created in the 2014 Farm Bill, and conservation districts across the country have successfully applied for, partnered with and led a large portion of all projects since the program's inception. The proposed RCPP rule implements changes Congress included in the 2018 Farm Bill. After receiving feedback from its members, NACD advocated for several changes and revisions to the law to ensure conservation districts and the locally-led conservation delivery process are prominent fixtures throughout the life of a project, from application to completion.

"Conservation districts should play an even larger role than they previously had in the implementation of RCPP projects," NACD President Tim Palmer said. "Their history of working together with local landowners, NRCS and partners in the conservation delivery system will only help to further leverage project funds needed to protect our nation's natural resources."

NACD's comments emphasized Congress's request that conservation districts serve a larger role during the creation of a project in order to ensure local natural resource needs are being addressed in each project and expressed NACD's support for the successful locally-led conservation delivery system that landowners have known and trusted for decades.

"We appreciate NRCS continuing to support the locally-led conservation delivery system and look forward to the agency continuing to support the local decision-making process that conservation districts often lead," **Palmer said.**

#### New Mexico Names Winning Envirothon Team

Congratulations to the Hot Springs High School team from Truth or Consequences Providence for winning the New Mexico state Envirothon competition held virtually from May 8-9.

There was a total of six teams from northern and southern New Mexico. The New Mexico state Envirothon would like to thank all of its conservation partnership agency volunteers, teachers and student

In 2018, **Stearns County Soil and Water Conservation District** (SWCD) in Minnesota was able to hire **Mark Greve** as their soil and water engineer-in-training thanks to an <u>NACD Technical Assistance (TA) Grant</u>. The district had previously been lacking the technical support for conservation practices that required engineering tasks such as surveying and design.

District Administrator **Dennis Fuchs** is very thankful for the opportunity the 2018 TA Grant provided.

"It was used to bring on a new generation of professionals to ensure that skills, expertise and relationships are available locally to implement voluntary conservation projects," **he said**.

Since joining the team, Greve has assisted with designs for Environmental Quality Incentives Program (EQIP)-eligible practices, including grassed waterways, alternative inlets, manure management and sediment control basins.

"Landowners are really short on time to spend with us because they have so many demands on their time," **Fuchs said**. "Having a person like Mark join our team to provide that engineering assistance in a way that is very farmer-friendly has been a great way to provide technical assistance in a way that ensures they actually enjoy working with us."

Greve has been able to provide assistance to landowners interested in the Minnesota Agricultural Water Quality Certification Program (MAWQCP), a program that recognizes landowners who worked to protect their surface waters and groundwater. Through the assessment of a landowner's property, conservation practices that could improve water quality are identified. Some of these practices might require engineering assistance, which Greve provides, such as rock inlets or buffers for waterways.

Producers subject to the Minnesota Buffer Law have also received assistance from Greve to implement conservation practices along their public waterways. A practice frequently implemented has been a controlled tile inlet, which filters and slows surface water entering the inlet. Greve's assistance has caused some landowners to become more open to conservation practices.

The **Ashland Soil and Water Conservation District** (SWCD) is sharing the world of conservation and urban agriculture with atrisk students in Ohio through a \$44,000 <u>NACD Urban Agriculture Conservation (UAC) grant</u>.

Initially, the grant was secured with the plans to conduct monthly hands-on educational visits to seven Head Start classes this spring, as well as partnering with local FFA chapters to build raised beds for the Head Start centers' gardens beginning in April. When Ohio closed all public schools and daycares in response to COVID-19, Ashland SWCD switched gears.

The funds helped hire Urban and Education Specialist **Becca Vales**, who, although hired in the midst of Ohio's stay-at-home order, hit the ground running with online lessons and social media posts.

Vales developed printed materials for Head Start programs, which the teachers could send to students' homes every two weeks. This was also supplemented with a "#TeacherTuesday" video series, where students can tune in and follow along with the lessons and programs.

"This is not the way we anticipated launching our grant programming, and the topics we're covering are not necessarily the same topics we would have covered in the classroom as we prepared to install raised bed gardens," **Ashland SWCD Program Administrator Jane Houin said**. "But I feel like we've turned lemons into lemonade."

"We could have thrown our hands up and said, 'we just can't do it right now,' but instead, Becca and the rest of our staff have gone above and beyond to continue to connect with those students and teachers, and the feedback has been fabulous," **Houin said**.

Head Start centers in surrounding counties, parents doing homeschooling activities, and teachers in the local and surrounding public schools are all requesting, accessing and sharing the videos, resulting in thousands of hits, she said.

For the tree sale this year, they gave each of the 107 Head Start students an apple tree seedling. The conservation district also distributed an additional 583 seedlings to students and teachers who drove through for Arbor Day, along with a learning packet of information on trees to connect with one of Vales's April lessons. Houin said the district plans on moving forward with the initial plans in the fall, and the FFA chapters will still create raised beds. But in the meantime, they are reaching, educating and connecting with more students and people than they ever imagined.

"I really just could not be more proud of our staff and the way they've adapted to meet the needs of our community during this challenging time," **Houin said**. "We've forged stronger relationships with our teachers and community members, and we've connected with such a large number of people who now know [about] Ashland SWCD and at least a little bit about what we do, and they know we care about our community and meeting our community needs."



On June 1, NACD submitted comments to the Bureau of Land Management (BLM)'s **Draft Programmatic Environmental Impact** Statement (PEIS) for Fuels Reduction and Rangeland Restoration in the Great Basin. The PEIS would help streamline the National **Environmental Protection Act** (NEPA) process, allowing for faster implementation achieved by allowing local BLM field offices to meet the timelines and page limits set forth by the national BLM office.

Additionally, NACD urges BLM to expand more programmatic NEPA analysis for other BLM managed public lands improvement projects.

# COVID-19 CAN'T STOP CALIFORNIA'S MONARCH BUTTERFLY CONSERVATION EFFORTS

In response to a drastic decline in the population of western
monarchs, California's resource conservation districts (RCDs) are
working with land managers and communities to protect and

Earlier this month, the **California Association of Resource Conservation Districts** (CARCD) announced the recent award of grants to 11 resource conservation districts (RCDs) located throughout California to fund monarch conservation projects.

The western monarch butterfly population has declined more than 99 percent in the past 20 years. Researchers have determined that the most important strategies to bolster the western monarch population include protecting and restoring overwintering sites, providing nectar resources along the migratory flyway, and increasing the availability of early-season native milkweed. They have determined that the next several years will be a critical time to bring back the butterflies from a path to extinction.

In 2019, the Wildlife Conservation Board awarded CARCD a block grant in order to provide sub-grants to RCDs through a competitive process. RCDs will use the grants to enhance up to 11 monarch overwintering sites, develop nine habitat restoration projects, and conduct outreach and education to continue expanding conservation efforts.

"RCDs already work directly with state, federal and local agencies, landowners, communities and other stakeholders, so they are perfectly situated to create monarch habitat throughout the butterfly's range in California," **said Karen Buhr**, executive director of CARCD. "Even though COVID-19 has kept staff sheltering in place and away from the field, RCDs are continuing to work during these challenging times to conserve the iconic monarch for future generations."

The RCD recipients of the grant are the Alameda County RCD, the Coastal San Luis RCD, the Gold Ridge RCD, the Grasslands RCD, the RCD of Greater San Diego County, the Mariposa County RCD, the Riverside-Corona RCD, the RCD

# FORESTRY SUPPORT IN SONOMA COUNTY WITH AN NACD TA GRANT

Thanks to an NACD Technical Assistance (TA) Grant, the Sonoma Resource Conservation District (RCD) in California has their first ever professional forester. The district had wanted to bring someone on for a while, but they didn't have the funds until 2018, when they were awarded their first TA grant. The grant allowed them to bring on Jason Wells as their registered professional forester.

According to Wells, interest in forest management was spurred by two fires in 2017, one of which burned through the city of Santa Rosa.

"The RCD started being bombarded with questions about forest management, and they didn't have anyone on staff that was capable of doing that," **said Wells**. Thankfully, now they do.

"Without this grant, I wouldn't have been hired," he said.

Wells works closely with their neighbor, **Gold Ridge Resource Conservation District**, to address forest health issues throughout Sonoma County. The county spans approximately one million acres, about 500,000 of which are forested.

"We consider forests anything that has a tree canopy cover about 10 percent or more," **Wells said**.

It will also include presenters from the American Water Works Association and Environmental Protection Agency (EPA) Region 1, who will highlight



Wells spends most of his time working with landowners to develop Forest Management Plans using a California Cooperative Forest Management Plan template, which will allow landowners to access cost-share funds. These plans work to meet the goals and objectives set by the landowner, which Wells also often helps create.

"I think one of the biggest things about my position is that because forest management really hasn't been something that people think about very much in this area, a lot of what I'm doing is providing general knowledge to people about forest management," **Wells said**. "Why should you do this? Why is this a beneficial thing? How is this working to create a working, better ecosystem?' All of those kinds of things."

Wells has spent time helping various partners in the county develop a Prescribed Burn Association (PBA), which helps bring people together to prevent wildfires.

"A PBA is landowners helping landowners bring fire onto their property," **Wells said**. He also offers insight into community wildfire protection plans, which identify fire-prone areas and recommend treatment methods, and participates in many community workshops that focus on wildfire risk and forest heath.

The grant also gave Wells the opportunity to expand his knowledge base, learning about the local programs that could help landowners.

"I've had the opportunity and the funding source to spend time researching everything. So, now, when I go talk to a landowner, I'm very comfortable knowing what they have available to them," he said. "That, I think, was the biggest thing about this first grant."

#### AFT Releases Farm Report

On May 20, American Farmland Trust (AFT) released a new publication, "Farms Under Threat: The State of the States." This groundbreaking report reveals that 11 million acres of agricultural land were paved over, fragmented, or converted to uses that compromise agriculture between 2001 and 2016, an area equal to all the farmland devoted to fruit, nut and vegetable production in 2017. Of these 11 million acres, more than 4 million were converted to urban and other highly developed uses, while nearly 7



# FORESTRY NOTES Q&A: SAF CEO TERRY BAKER

Terry Baker (pictured) joined the Society of American Foresters (SAF) as chief executive officer in September of 2018. Hailing from Marianna, Fla., he has worked in seven states for the U.S. Forest Service. Baker earned a bachelor's degree in forestry from the University of Florida in 2004 and a master of forestry degree at Yale University in 2007. He also holds a bachelor's degree in agricultural sciences from Florida A&M University. Terry and his wife, Jessica, reside in Washington,



D.C. Recently, he shared time with NACD to discuss his work at SAF.

What factors do you believe are critical for forestry to achieve workforce needs over the next decade?

The major factors that I see impacting our ability to address workforce needs over the next decade are awareness, training and career pathways. With an example like the Trillion Trees Initiative, forestry and natural resources management are finally being more widely recognized as part of the solution to carbon and economic issues. As professionals in this area, we have long known this to be true, but we must be willing to adapt and engage the broader public and new audiences versus sitting back and seemingly touting, 'We told you so!'

One way SAF is working to spark new interest in forestry careers is through a partnership with the Sustainable Forestry Initiative to help create and distribute a new Project Learning Tree course, "Green Jobs." We felt this was a great way to increase awareness of our professions to students and teachers. The ability for students to see themselves solving natural resource issues and for teachers to see our professionals as part of the solution sets a great foundation in building our future workforce.

# TECHNICAL ASSISTANCE FOR WATERSHED IMPROVEMENT IN NEBRASKA

Since 1972, the Middle Niobrara Natural Resources District (MNNRD) has been devoted to helping solve natural resource issues in their area. Many of those issues revolve around erosion and water quality in the Long Pine Creek Watershed. This watershed, which is found in north central Nebraska, encompasses approximately 332,000 acres, many of which are designated for agriculture.

To help with these issues and improve the watershed, the district has utilized a variety of programs, including the USDA-NRCS Environmental Quality Incentives Program (EQIP), along with grants through the Environmental Protection Agency's (EPA) Nebraska Department of Environment and Energy (NDEE) 319 Nonpoint Source and Nebraska Environmental Trust (NET) programs. However, even with the funds from these programs, MNNRD found they lacked the technical support needed to complete projects.

That changed in 2018 when the district received its first NACD Technical Assistance Grant, which allowed them to bring on Chandler Schmidt as their watershed coordinator. Schmidt, who previously worked for NRCS in Illinois and Nebraska and with the U.S. Fish and Wildlife Service in Mississippi, has assisted in the completion of a multitude of diverse projects.

One of the major projects Schmidt's been working on is the SD-14 Rehabilitation Project, which is aiming to maintain stream elevation, reduce erosion, and decrease excess sediment. The project is putting in a three-tier engineered rock riffle structure in Sand Draw Creek to prevent stream degradation. The project was completed this past May.

"We were able to assist in replacing the structure to manage water and enhance the water course," **Schmidt said.**


# The Voice of a Future Conservationist

Scotty Herriman, a life-long, full-time farmer and a veteran of the U.S. Army, owns and operates Herriman Farms in South Coffeyville, Okla., with his wife Jo. After farming for over 50 years, Herriman has seen many extreme weather events and experienced their devastation. It wasn't until 2010, however, that he visited the USDA-Natural Resources Conservation Service (NRCS) field office and decided to switch to a no-till operation with the assistance he received through the Environmental Quality Incentives Program (EQIP). After decades of conventional farming, Herriman said they switched overnight.

At first, the Herrimans described their field as the ugliest in the county due to the crop residue from no-tilling. But after experiencing the many benefits of a no-till operation, the Herrimans just had to adjust their opinions on what constitutes an "ugly" field. The benefits they saw included a decrease in fuel and equipment costs and a reduction in their fertilizer usage. The health of the land also improved – the crop residue was protecting the soil from extreme temperatures and erosion. So, now, the Herrimans see exposed soil without residue to be an eyesore.

In 2016, Herriman decided he wanted to take things further and incorporate cover crops into his operation. This past year, due to flooding, Herriman decided he had to plant soybeans even though he wouldn't be able to harvest them until nearly the first frost. Normally, he would plant his cover crops as he harvested the beans, but this new timeline was too late in the fall to get his cover crops established. Not only was Herriman looking to fight soil compaction with his cover crops, but he had a contractual obligation with EQIP to get them planted. So, Herriman had the idea to aerial seed his cover crops instead, which was successful.
