- California State Parks OHV Grant: Long met with Jennifer Taylor of BLM. BLM will do the GIS mapping portion of the grant. They discussed the timeline so that when the next grant application period comes up we can apply for a restoration grant.

 - -City of Murrieta's General Plan: still reviewing and making comments.
 - -distributed the new Clean Water Act document that deals with non-contiguous watercourses.
- -Friends of Riverside Hill's case was successful and clarified the HANS process. It was determined that the HANS is a recommendation and an environmental review will be necessary for any parcels that are determined at less than 100% conservation.
- -The City of Perris is converting prime agricultural land to industrial projects. Johnson is suing in these cases based on CEQA mandates and state mapping of agricultural lands.
- -Wheeler asked what is happening with the new MS4 mandate? Not much is known but lawsuits have been filed and questions about financing these changes in regulations were discussed.

--Firesafe Counsel report: Wheeler reported that they are finishing up the "chipping" grant on the Plateau.
