Funding Opportunities

Coastal Conservancy Draft Guidelines for Prop 68 Funding

The State Coastal Conservancy has posted [draft guidelines for the Proposition 68 San Francisco Bay Climate Funds grants](#). Comments on the guidelines will be accepted through Friday, July 19. Comments will also be accepted [at two public workshops](#), June 6 (Redwood City) and June 27 (Oakland).

DOC Local and Regional Planning Projects Grants

The Department of Conservation has \$950,000 [for Local and Regional Planning Grants program](#) to support the integration of natural and working lands, specifically agricultural lands, into local and regional planning documents. Grant applications are due Wednesday, July 31. Comments may be submitted via email to CFCP@conservation.ca.gov.

USDA NIFA Sustainable Agricultural Systems Funding

The USDA's National Institute for Food and Agriculture is currently accepting applications for the [2019 Agriculture and Food Research Initiative - Sustainable Agricultural Systems Grant](#). Proposals must focus on approaches that

promote transformational changes in the U.S. food and agriculture system within the next 25 years. Applications are due Thursday, September 26.

NRCS Conservation Innovation Grants

USDA's Natural Resources Conservation Service is investing up to \$12.5 million to help support the adoption of innovative conservation approaches on agricultural lands through their [Conservation Innovation Grants \(CIG\) program](#). They will be accepting proposals through July 29. [A webinar for applicants](#) is scheduled for June 11 at 12pm ET (9am PST).

Advocacy & Legislation

Legislative Update

We are excited to announce that our [2019 Legislative Update](#) is available in the RCD member dashboard ([or download a PDF with this link](#)). This document outlines the main bills we will be supporting and pushing for at the State Capitol. The update includes information on SB 253 (the Environmental Farming Incentives Program), AB 933 (Ecosystem Resilience Program, aka Watershed Coordinator Program), SB 45 (Climate Resilience Bond), and numerous forest and fire bills. We encourage RCDs to take a look.

RCD News

Mendocino County RCD Navarro Watershed Citizen Science

A new effort to monitor stream health throughout the Navarro River watershed is being led by the Mendocino County RCD. They are looking for streamside landowners who would be willing to monitor water temperature to aide efforts around the health and recovery of native Coho Salmon and steelhead trout. A workshop will be held on Saturday, June 1 at 9am to 11am, starting at the Rose Room in Boonville (Little Red Schoolhouse) and then moving to the nearby stream for an on-site demonstration. The RCD will install a water temperature sensor and demonstrate how to access the water temperature data with a smartphone. Please RSVP by emailing linda.macelwee@mcrccd.org.

Solano RCD and San Joaquin County RCD Awarded Delta Conservancy Board Grants

Congratulations to Solano RCD and San Joaquin County RCD, which were both [awarded funding from the Delta Conservancy Board](#) through the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1) Grant Program.

- Solano RCD's Delta Working Waterways Habitat Restoration Planning Project (\$347,481) will plan for restoration and enhancement of waterways and edge habitats on working lands in Solano County.
- San Joaquin County RCD's Paradise Cut Conservation and Flood Management Project, Phase 2 (\$265,254) will include outreach and planning to advance the Paradise Cut Flood Bypass in San Joaquin County.

Contra Costa RCD Rodeo Creek Cleanup

Join the Contra Costa RCD and the John Swett High School Ocean Conservation Club on Saturday, June 8 for a [Rodeo Creek Cleanup](#). They will meet in the Safeway Parking lot (605 Parker Ave. Rodeo, CA). All ages are welcome to participate and children under 18 must have parent or legal guardian present to sign a waiver. Lunch will be provided to participants of the cleanup. RSVP to receive the waiver in advance.

Carbon Farming in Marin Featured in Marin Independent Journal

The Marin Independent Journal featured news of the [Wildlife Conservation Board's \\$1.4 million carbon farming funding announcement](#), touching on both the role of RCDs at the state level, along with ongoing work from Marin RCD and the Marin Carbon Project. "The state is partnering with 10 resource conservation districts including Marin's to set up pilot farms that have set up carbon sequestration and habitat improving amenities such as wind breaks to reduce evapotranspiration of water from the soils, row crops in orchards to sequester carbon and improvements to local creeks, for example."

Conservation Announcements

CSU Chico Soil Health Workshop

CSU Chico's Regenerative Agriculture Institute is hosting a [workshop on cover crops and soil health](#) from June 24-25 at CSU Chico. Dr. Christine Jones will be talking about soil health, carbon sequestration, and importance of microbial communities. Dr. David Johnson will also be joining on Day 2 with a BEAM composter demonstration and testing. There will also be a Farmer's Forum Discussion panel.

Collaborative Conservation and Adaptation Strategy Toolbox

The Southwest Climate Hub, US Fish and Wildlife Service, Bureau of Reclamation, and Forest Service have collaborated to create [the Collaborative Conservation and Adaptation Strategy Toolbox \(CCAST\)](#). It is a library of conservation case studies on monitoring, management actions, and adaptive management. Studies can be browsed by topic, or by an interactive story map.

DOC Sustainable Agricultural Lands Conservation Workshops

[The Sustainable Agricultural Lands Conservation Program \(SALC\) workshops](#) will be held on Monday, June 3 in Modesto, Monday, June 17 in Escondido, and Tuesday, June 18 in Ventura. The workshops are sponsored by the Strategic Growth Council and the California Department of Conservation in collaboration with the Mayor of Modesto and the Farmland Working Group. The purpose is for participants to learn more about SALC grants and to engage leaders from across the region who have deep knowledge about how to best retain our valuable agricultural lands

and important farming industry. The planning grant pre-proposal deadline is July 15, and the planning and easement grant application deadline is September 13.

UC ANR Drone Workshop

[The third annual DroneCamp](#) will be offered from June 18-20 by UC Agriculture and Natural Resources' Informatics and GIS Program. People who are interested in using drones for real-world mapping are invited to attend a three-day intensive drone workshop in the Monterey Bay area. No experience with drone technology is needed to participate. Drone mapping involves taking high-resolution photos with drones and stitching them together with software to make extremely accurate, orthorectified maps. More difficult than videography, it is widely used in agriculture, construction, archeology, surveying, facilities management, and other fields. A registration fee of \$900 is due by June 1.

Amador RCD Hiring Natural Resource Specialist

The Amador RCD is seeking applications from an individual for an at-will employee to provide technical assistance to landowners as [the Natural Resource Specialist I](#). The employee will work with ARCD District Manager and NRCS staff to assist landowners in writing conservation plans and applying for funding assistance through the Environmental Quality Incentive Program (EQIP). The employee will assist members of the ARCD program, the Sacramento/Amador Water Quality Alliance, to comply with the Irrigated Lands Regulatory Program (ILRP) through education and technical assistance. Applications should be submitted before June 14.

Program Services Specialist with Stopwaste

Alameda County Waste Management Authority (also know as StopWaste) has an opening for a [Program Services Specialist I or II](#). This position will provide support to the Agency's Community Based Outreach Project team, as well as have a commitment to the mission of the Agency. The Community Based Outreach team provides oversight and implementation of field outreach to support the Agency's priorities: waste prevention and the food cycle, with a focus on residents and community partners. This team coordinates closely with the Schools Community Based Outreach Team.



Science, Technology, and Monitoring Program Highlights

Lessons Learned in Stormwater Monitoring

The San Antonio River Authority is among the many agencies pushing for the implementation of Low-Impact Development (LID) and Best Management Practices (BMPs) to reduce the impacts of urban stormwater runoff on receiving watersheds. Program Highlights

Drinking Water & Working With Ag

This year's River Rally program is chock full of sessions designed to educate and inspire your work. Check out these highlights.

Pursuing Safe, Clean and Affordable Drinking Water

Everyone needs safe, clean and affordable water to drink. However, drinking water may not be as safe as generations of Americans have come to expect and a growing number of people in our country face unaffordable water bills while water utilities struggle to fund maintenance or replace aging pipes. How do we address these challenges in both urban and rural areas? If your work touches these and other related challenges, we invite your workshop submission. Workshops include:

Nutrient Pollution: Dead Zones and Other Messes

This workshop provides an overview of nutrient pollution from policy and scientific perspectives, with a particular focus on the Great Lakes. We will address the current regulatory atmosphere, the Gulf of Mexico Dead Zone, and how the nutrient pollution has harmed drinking water supplies, injured sport fishing, and created dead zones in Lake Erie.

Presenters: Albert Ettinger, Albert Ettinger and no Associate; Molly Flanagan, Alliance for the Great Lakes; Matt Rota, Gulf Restoration Network; Dr. Jeff Reutter, Ohio State and Ohio Sea Grant

Finding Common Cause for Clean Drinking Water



Attached you will find the updated proposal for Fairway Estates. As expected, it has been over a year since this first proposal went out to your location and unfortunately labor and Fish and Wildlife fees have increased. The costs include the following:

*All tools, material, reports, staff time and mileage to conduct 2 days of non-native species removal and limbing of native horizontally growing vegetation up to 4 feet.
