

## TAKE ACTION

### Some Special Districts Will Receive Unpaid Mandate Reimbursements

Following the passage of AB 74 as part of the California State Budget, certain districts will be receiving reimbursement checks for mandates going back almost 20 years. The 2019-20 State Budget Act contains \$15.1 million of funding for four (4) different "Expired and Repealed Mandates" for costs dating back as far as 2001-02. Of the four funded-programs, two of them involve reimbursable costs for special districts. Those two programs are:

- Fire Safety Inspections of Care Facilities (Ch. 993, Stats. 1989) (01-TC-16 and 13-MR-01)
- Local Recreational Areas: Background Screenings (Ch. 777, Stats. 2001) (01-TC-11 and 12-MR-02)



## Welcomed New Project Coordinator

Sara Letton has joined [our team](#)! Sara is CARCD's new project coordinator and will transition to leading CARCD's conservation cannabis project and water use efficiency projects. In the past she has worked with Western Shasta RCD and her familiarity with RCDs is a great asset. She can be contacted at [sara-letton@carcd.org](mailto:sara-letton@carcd.org).

## Salmonid Recovery with Department of Fish and Wildlife

We are participating in the Department of Fish and Wildlife's working group on North Coast salmonid recovery. The group is working on a new assessment that incorporates information on local activity such as landowner participation

and active conservation organizations. This incorporation of local knowledge will make RCD salmonid restoration efforts more effective.

## Noxious and Invasive Plant Committee

The Noxious and Invasive Plant Committee is an important part of coordinating state and national weed management. June's call focused on seed delivery and weed free materials. We are glad to be involved on the calls on behalf of RCDs so that we can more effectively manage weeds and make sure RCDs are seen as a primary organization for invasive plant management.

## TNC Water Transaction Network

The Nature Conservancy has been engaging CARCD and other partners in their Water Transaction Network. CARCD met with TNC to talk about how RCDs might be engaged in water transactions for species recovery. Voluntary in-stream flow transactions have become an important conservation tool and we hope to expand RCDs' ability to leverage it.

## California Conservation Corps Partnership

We met with the California Conservation Corps to discuss how the CCC and RCDs can better partner together. Corps members are an important force for on-the-ground conservation projects, and the stronger our partnership is, the more CCC and RCDs can increase each others' effectiveness and visibility.

## Specialty Crop Block Grant

CARCD has been working to advance our Specialty Crop Block Grant proposal for [the California Farm Demonstration Network](#). This multi-partnership initiative will allow producers to learn from each other to increase soil health, improve water quantity, and improve conservation on their properties.

## CALFIRE Partnership

We met with Thom Porter, the new director of CAL FIRE, to discuss the partnership between CAL FIRE, RCDs, and CARCD. This is a key partnership to strengthen as RCDs continue to work on wildfire and forest health issues. We are currently [supporting several legislative bills](#) which will increase funding for wildfire prevention and restoration work, and one which will specifically increase our ability to partner with CAL FIRE on defensible space.

## Division 9 Revisions

Division 9 is under revision by the Department of Conservation, and CARCD has convened a committee to draft proposals for Division 9 revisions which would best serve the interests of RCDs. We have been working closely with the Department of Conservation and with RCD District Managers and directors from across the state representing a diversity of regions and capacities. The RCD Division 9 committee had several phone calls in June to identify key objectives and draft language for the themes of the state role and vision, local regulation, and larger opportunities.

## Funding Development

We have been working with our Advancement Consultant, Monika Whitfield, to create a development plan for CARCD and RCDs. By networking with foundations and growing the individual giving campaign, we hope to diversify and increase funding for RCDs.

## NACD ED Conference

CARCD will be hosting this year's annual National Association of Conservation Districts Executive Directors Conference, which will be generously co-hosted by Tahoe RCD. This conference will bring together executive directors from state associations of conservation districts from across the country. This will be an opportunity for us to learn best practices from across the country, and to share about our successes in capacity building and increasing visibility of RCDs.

## SB 253 Testimony and Hearings

SB 253, the bill to create the Environmental Farming Incentive Program, is now making its way through the California State Assembly. CARCD has co-sponsored the bill, and has been working with lawmakers to amend it to explicitly include RCDs in its language. In June, CARCD testified at the Capitol when it was heard by the Assembly Natural Resources Committee.

## CSDA Collaboration

The California Special Districts Association has asked us to share how RCDs use special tax assessments and fees. The goal is to better understand how they are used so we can better leverage them where they are appropriate.

## American Farmland Trust

CARCD has been working with American Farmland Trust to strategize outreach to underserved producers. This has been an important direction for both organizations as reaching all producers will make RCDs more relevant and help us fulfill our mission of serving all district residents.

## Bechtel Funded Diversity, Equity and Inclusion Training

CARCD has an exciting opportunity to participate in a Diversity, Equity, and Inclusion (DEI) deep dive training funded by the Bechtel foundation. Participants are environmental leaders from across the state. Three trainings of 3-5 days each will culminate in a plan to incorporate concepts into the CARCD work plan and pass core learning on to RCDs across the state. Along with CARCD, Peter Braudrick of the Mendocino RCD and Sheryl Landrum from the RCD of Greater San Diego are also participating.

## CA Landscape Stewardship Network

CARCD has been convening with the California Landscape Stewardship Network about how several conservation networks can better collaborate amongst themselves. This "networking of networks" will reduce redundant efforts, make conservation efforts effective, and help with information sharing.

## Conference Planning

CARCD continues to plan for the 74th Annual CARCD Conference in Redding. The team has been building the agenda and coordinating with the venue to plan a relevant, excellent, and visible conference for the RCD network.

## WAFWA Monarch Butterfly Coordination

CARCD joined the Western Association of Fish and Wildlife Agencies' Western Monarch Butterfly Population Take Flight Conservation Meeting. The meeting and partnership with WAFWA will help the RCD network coordinate with other conservation efforts for butterfly recovery.

## Bay Area Sustainability Plan

CARCD is participating in the Bay Area Open Space Council's planning committee to create a sustainability plan to support conservation in the Bay Area. This is an important part of making sure RCDs are seen as relevant and effective organizations for implementing conservation in the Bay Area.

## NRCS Local Agreements

CARCD have been working with USDA NRCS and the Department of Conservation to write a Memorandum of Understanding to set local agreements with NRCS offices. Stronger local agreements will help RCDs coordinate better with NRCS staff.

## Streamlining Watershed Permitting

CARCD has been part of a working group that includes state water control boards, USDA NRCS, and Cal EPA. The group meets with the goal to streamline permitting and promote watershed pilot projects around enhancing watershed functions. Reducing permitting load is crucial for effective watershed conservation efforts going into the future.

## DOC Quarterly Meeting

CARCD had its quarterly meeting with David Bunn, Director of the California Department of Conservation, which included discussion about potential revisions to Division 9, advanced payments, bond funds, and ways that RCDs and DOC can collaborate. CARCD also has monthly check-ins with the staff and leadership of the Division of Land Resource Protection.

## Partnership with Carbon Cycle Institute

CARCD is making a concerted effort to work more closely with CCI. The two organizations are now holding monthly partnership meetings and connecting on various projects between meetings. The intent is to strengthen the RCDs ability to implement carbon farming by providing funding and technical assistance.

## John de Graaf

CARCD has been in conversation with John de Graaf, keynote speaker at the CARCD Conference in 2018, who promotes the view that the beauty of natural spaces is valuable because it enhances quality of life. He is interested in increasing the public's awareness of RCDs.

## Durable Collaborations

Over the past few years, CARCD has secured state and private funding to support six RCD durable collaboration explorations throughout the state. With the guidance of CARCD and Solid Ground Consulting, the North Coast cohort has been working together since 2016 to outline their goals and create a clear path forward to achieve their objective of being able to contract as region with state and federal funding partners. In June, CARCD staff co-facilitated a call with the Sacramento Valley durable collaboration cohort.

## WCB Monarch Butterfly Block Grant

CARCD submitted a full proposal for a block grant to the Wildlife Conservation Board's Monarch Butterfly and Pollinator Program. The application was developed after careful collaboration with RCDs. The funding would be allocated to individual participating RCDs to create a patchwork of continuous habitat for the Western Monarch Butterfly's migration flyway.

## NRCS Conservation Planner

CARCD's program manager, Kristen Murphy, attended the NRCS Conservation Planner training on Staten Island in the Sacramento-San Joaquin Delta, with the intention of CARCD better understanding and being able to support RCDs with technical assistance and on-the-ground work.

## Colusa County RCD Carbon Farm Plan

CARCD participated in Colusa County RCD's first carbon farm plan producer meeting. The meeting went well and CARCD is looking forward to further supporting RCD carbon farm planning efforts.

## Engaging with Ranching Networks

CARCD attended the California Cattlemen's Association's mid-year meeting in Rancho Murieta and connected with CCA President Mark Lacey. This is part of an effort to further engage the ranching community as part of the Grazing Lands Coalition funding.

## Sierra Nevada Alliance and the Sierra Corps Program

CARCD is serving on the steering committee for the Sierra Nevada Alliance's new Sierra Corps program. The program is funded through a grant by the Sierra Nevada Conservancy, and aims to build the capacity of local organizations in the Sierra Nevada through the placement of skilled corps members in organization offices.

## California Forest Stewardship Education Initiative

The Landowner Education and Outreach Working Group of the Forest Management Task Force proposed the creation of the California Forest Stewardship Education Initiative. The Initiative, led by UC Cooperative Extension and funded by CAL FIRE, will use workshops to enhance private forest landowners knowledge of forest management activities and technical knowledge throughout the state. CARCD is serving on the steering committee and will work to ensure this initiative is strategically aligned with RCD priorities and draws on RCD expertise in landowner education and outreach.

## CARCD Updates

## Website Requirements for Special Districts

A recent change to government code will require all special districts in California to have a website by January 1, 2020. There are still many RCDs that do not yet have a website, and even if yours does it would be a good idea to confirm that it meets all requirements. If you're wondering what needs to be included on a website you can find [a website compliance checklist for special districts at this link](#). Best Best & Krieger also published [a helpful article about the new law](#), including information about a possibility for exemption due to financial hardship.

Recognizing that this new law might pose a burden (financial or otherwise) to some RCDs, CARCD secured funding from a foundation to create a website template in WordPress that our member districts can use as a starting point. This is meant to save RCDs any expense that might be incurred for website design, which can be very costly. The template is scheduled to be ready by September and will include training materials. CARCD staff will also be able to provide some staff support with helping RCDs get their website set up for the first time. The website template will be free for dues paying members, but the RCDs will still need to pay for web hosting through a service provider like GoDaddy. ### Sierra Nevada Conservancy Publishes Monthly List of Grants

### WCB Announces Stream Flow Enhancement Program

The Wildlife Conservation Board has released [the 2019 Proposal Solicitation Notice for the Stream Flow Enhancement Program](#). Funds granted under the program are prioritized towards enhancing flow in streams that support anadromous fish; support special status, threatened, endangered, or at-risk species; and/or provide resilience to climate change. Up to \$64 million is anticipated to be available through the 2019 Solicitation. Projects should be completed by April 30, 2024. Grant applications will be due by September 10.

### Sonoma RCD's Range Tailgate 2: Cows, Compost + Carbon

Sonoma RCD's workshop [Range Tailgate 2: Cows, Compost + Carbon](#) will be on Tuesday, August 27 from 9am to 11:30am. The address will be provided upon registration. The RCD and Sonoma Mountain Institute invite ranchers and prospective ranchers to come learn the latest findings from their Healthy Soils Demonstration Project. Starting in 2018, on a private 300-acre ranch owned by the Sonoma Mountain Institute, this demonstration field trail was established to look at how compost application influences soil health and forage productivity on a working rangeland. The tailgate will include a discussion on the comparison of baseline versus year one soil samples on both treatment

### EDF's Groundwater Simulation Tool

The Environmental Defense Fund and the University of Michigan have created a hands-on simulation that educates players about the challenges and solution strategies of groundwater management called [the Groundwater Game](#). The simulation has proven to be a powerful engagement tool to bring diverse stakeholders together and facilitate a thought-provoking dialogue as they work through various groundwater management scenarios. EDF has facilitated the simulation with elected leaders, community members and students for more than a year. A new toolkit allows organizations to facilitate simulations in their own communities. ### Elderberry Hedgerow Field Day in Dixon

The Agricultural Sustainability Institute is hosting [an elderberry field day](#) on Tuesday, September 17 from 1:30pm to 5:30pm at the Cloverleaf Farm (8946 Olmo Ln, Dixon, CA 95620). Native hedgerows on farm edges benefit wildlife, pest control, carbon storage and runoff, but hedgerow planting by farmers in California is limited, often due to establishment and maintenance costs. What if hedgerows could provide a source of farm income to offset costs? The field day will include an elderberry tour, a value-added product discussion and demonstration, and a presentation on ecological benefits and nutritional analysis.



## DO YOU KNOW YOUR DISTRICT'S SOCIAL MEDIA POLICY AND GUIDELINES?

With 3,000 conservation districts across the country, there's no shortage of success stories, district updates and more. Many districts use some form of social media channel (Facebook, Twitter, Instagram and/or LinkedIn) to share what they're up to.

As an employee, you are probably familiar with the type of content your district posts and shares, but **did you know that your district may have specific guidelines for posting content?** Do you know who in your district has administrative responsibilities/roles when it comes to posting content?

NACD recently created a [Social Media Guidelines and Best Practices document](#) meant to assist districts and board members in best social media practices when it comes to posting content and engaging online. These guidelines will help districts either create their own social media policy or build on and strengthen their existing policy. Establishing a social media policy for your conservation district's social media channels is important in maintaining a consistent brand and image.

There are several important questions to consider when it comes to developing a social media policy for your district:

- **What is the process** for posting content on a district-sponsored social media account?
- **What existing modes of communications** does your district have? How do your social media channels engage/interact with these other modes of communication?

### Last Day to Submit CIG Proposals

On May 30, USDA announced \$12.5 million in funding through 'classic,' national Conservation Innovation Grants (CIG). **Today is the final day to submit your proposal!**

The Natural Resources Conservation Service (NRCS) will accept proposals through **July 30**, and all U.S.-based non-federal entities and individuals are eligible to apply.

2019 CIG priorities are increasing the pace and scale of conservation adoption; water quantity; pollinator habitat; and urban agriculture. This funding program is distinct from the \$25 million announced on May 15 for on-farm conservation innovation trials.



How's My Waterway is being designed to answer the questions: "How's My Drinking Water?," "Can I Fish?," and "Can I Swim?".




## Washington District Seeks Executive Director

As a first-generation farmer in North Carolina, **Russell Hedrick** is no stranger to challenges as well as opportunities. When Hedrick first started farming, he couldn't afford all the tillage equipment he was told he needed, so this pushed him immediately into a no-till operation. With the guidance of his local district conservationist, Hedrick started out 100 percent no-till and planted cover crops on part of his acreage. Within the first year, he saw the yields on the cover crop acres were much higher than the rest, and there was greater weed suppression.

Overall, Hedrick's first-year yields were also higher than the county average. As a result, he felt energized to do more and try new things in order to grow as a farmer. Over time, Hedrick's yields continued to be 20 to 30 percent higher than the county average, and he was able to reduce his fertilizer costs by more than \$95 per acre after only five years due to the nutrient boosts he received from the cover crops and increased amounts of carbon and biology in the soil. With his best cover crop mix costing \$45 per acre, his least expensive covers costing \$20 per acre, and the reduction in fertilizer costs, Hedrick found himself coming out ahead financially.

Hedrick has also partnered with [Foothills Distillery](#), where they produce moonshine, as well as the first bourbon in North Carolina since prohibition. His farm and the distillery are the perfect partnership, where if Hedrick wants to try something new in his distillery, he can grow it himself. His business has been helped tremendously by his direct-to-consumer marketing through social media platforms such as Facebook.

Hedrick and his partners in the distillery conduct tours of both his farm and the distillery to educate the public. His advice to farmers looking to incorporate soil health practices into their operation is to try something on 20 percent of your acreage. That's enough to see a difference, but also enough to leave a safety net if something doesn't work. There isn't a one-size-fits-all solution or silver bullet to soil health, so he encourages farmers to try different practices and see what works for them.

## CARCD Updates

## Website Requirements for Special Districts

A recent change to government code will require all special districts in California to have a website by January 1, 2020. There are still many RCDs that do not yet have a website, and even if yours does it would be a good idea to confirm that it meets all requirements. If you're wondering what needs to be included on a website you can find [a website compliance checklist for special districts at this link](#). Best Best & Krieger also published [a helpful article about the new law](#), including information about a possibility for exemption due to financial hardship.

Recognizing that this new law might pose a burden (financial or otherwise) to some RCDs, CARCD secured funding from a foundation to create a website template in WordPress that our member districts can use as a starting point. This is meant to save RCDs any expense that might be incurred for website design, which can be very costly. The template is scheduled to be ready by September and will include training materials. CARCD staff will also be able to provide some staff support with helping RCDs get their website set up for the first time. Hi RCDs,

Below is a great question "if RCDs that had the previous TA contracts are eligible to apply for the new one?"  
Please see the answer below:

1. The SWEEP program did not receive any new funding in the latest budget (19-20), but we do still have some money to expend from the appropriation that came to SWEEP in the 18-19 budget. For this reason CDFA will be utilizing the existing contracts for technical assistance when CDFA has the next SWEEP application period - expected this fall. The technical assistance would be limited to what was covered in the current agreements, essentially the application assistance. Post-award technical assistance won't be covered.
2. The HSP program and AMMP program both received new funding in the new fiscal year (19-20). This means that for these two programs CDFA needs to follow the new TA program for which we are currently accepting applications. Any organizations that wish to receive grant funding for TA for HSP and/or AMMP in the coming year need to apply for funding through the application that is open right now. CDFA **WILL NOT** utilize the existing contracts for these groups.

To summarize - the TA Grant Program is currently open and available for HSP and AMMP, and you DO need to apply for this new round if you'd like to continue providing outreach, application assistance, and pre- post- award TA. There is no SWEEP TA funding. However, those that have existing CDFA SWEEP TA funds can use them in the upcoming solicitation.

**ICYMI: Concurrent Session Takeaways**

During the 2019 NACD Summer Conservation Forum and Tour Luncheon, National Conservation Foundation (NCF) Chairman

**Steve Robinson** announced the opening of the application period for the inaugural cohort of the Next Generation Leadership Institute (NGLI).

NGLI, a program of the NCF, will train seven applicants over the course of 2020, with one participant selected from each of the National Association of Conservation Districts' (NACD) regions.

"The NCF has championed the development of future leaders of conservation since its inception," **Robinson said**. "We are excited to formally launch the NGLI application process today and look forward to working side-by-side with the inaugural participants to advance conservation leadership."

During the year-long NGLI program, currently-appointed conservation district officials will be equipped for leadership at the local, state and national level through several in-person trainings focused on personal, civic and organizational leadership development.

## SUMMER MEETING SPEAKERS DISCUSS CONSERVATION, LEADERSHIP



The Conservation Forum on Monday, Aug. 5, featured a diverse line-up of speakers.

New Mexico Secretary of Agriculture and President of the National Association of State Departments of Agriculture (NASDA) **Jeff Witte** (pictured above) welcomed meeting attendees to the state. "We live in an amazing state, and it's because of some of the work that you all do," **he said**. Witte described the state's acequias, calling them "the custom and the culture of this state." On Tuesday's Conservation Tours, NACD meeting participants will get to view acequias firsthand.

### Farm Bill Program Implementation

Natural Resources Conservation Service (NRCS) **Deputy Chief Jimmy Bramblett** gave an overview of how the 2018 Farm Bill is affecting NRCS' conservation programs, as well as the timeline for input and implementation.

### Building the Capacity and Coordination to Market Conservation Districts

Washington State Conservation Commission (SCC)'s Communications Coordinator **Laura Johnson** and NACD Board Member **Doug Rushton** gave an overview of the living marketing toolkit created by the SCC for conservation districts. Through their work, they have created templates, a branding kit, talking points and more to help the 45 districts in the state champion their collective mission.

### Local Work Group Training – Powering Up Your Local Work Group; Conservation Application Ranking Tool (CART)

**Ray Ledgerwood** and **Aaron Lauster** led a session on how to re-energize Local Work Groups (LWG) in order for participants to provide input on USDA and state conservation Programs. Participants also learned more about the NRCS Conservation Application Ranking Tool (CART) application.

### Invasive Species: Education to Eradication (Eventually) and Western Governors' Biosecurity and Invasive Species Initiative: Outcomes and Next Steps

**Otero SWCD's Victoria Milne** and **Western Governors Association's Bill Witacre** led a session on how to identify and develop an invasive species program, starting with a summary and discussion of the Western Governors Association's Biosecurity and Invasive Species Initiative and the resulting policy. Participants then learned how to put the plan to action.

### Watershed Restoration on the Canadian River



Meeting attendees also learned about the New Mexico Association of Conservation Districts' (NMACD) Conservation Officials Leadership Training (COLT) program and the Restore New Mexico initiative.

The COLT program began in 2018 through a grant from NACD and NRCS to administer a new leadership development program, to locate and identify younger, next generation district supervisors who have an interest in broadening their horizons and assuming greater leadership roles. COLT panelists described the program as a success, with two of the ten program participants serving in a national leadership capacity and several others in leadership roles within New Mexico.

Speaking about engaging new, younger audiences in conservation, COLT participant from Southwest Quay SWCD and the NMACD Region 5 Vice Chair **Kandy Hutchins (pictured)** said, "We have a lot of knowledge and wisdom that comes from our historical base and who we are, but we have to share that and pass that down. We have to continue that message and share who we are. What we do matters."

The panelists described how the COLT program helped to engage them and get them involved in the decision making process. **Casey Spradley** from Cuba SWCD described how she became a COLT participant after one conversation. "The goal of conservation is to provide for the future," **she said**. "To get the next generation involved, all it takes is a question."

NMACD Executive Director **Debbie Hughes** described the Restore New Mexico initiative, and how the state has partnered with the Bureau of Land Management (BLM) and the U.S. Fish and Wildlife Service to help put conservation on the ground in the state, reviving grasslands and wildlife habitat, thinning forests, and restoring acequias.

New Mexico State Representative **Jack Chatfield** discussed the chemical treatment of salt cedar, an invasive species that is spreading rapidly across the Southwest.

#### **Riparian Restoration on the Rio Grande**

**Nyleen Troxel Stowe** and **Will Kolbenschlag** from the **Socorro SWCD** introduced the Canadian River Riparian Restoration Project, which began in 2004 with 21 state and federal agencies involved, and is organized around the eight SWCDs that make up the Canadian River Watershed. Since then, it has established a monitoring program, mapped over 880,000 acres of riparian areas, and treated over 33,000 acres of salt cedar.

#### **Life is Better in the Shade: Preventing Water Loss in Your Stock Tank**

Through a cost-share program, **Roosevelt SWCD** in Portales, N.M. has been conducting research using "shade balls" on livestock water tanks since 2015. **Roosevelt SWCD's Mike Cone** discussed how the district has found measurable decreases in algae, debris, weeds, ice formation, and most importantly - water evaporation.

#### **Sierra SWCD Cost Share Program: Helping People Help the Land**

Soil and water conservation districts work in many ways to assist private landowners. **Sierra SWCD's Travis Day** led the session by describing the district's cost-share program aimed to help landowners implement conservation, from fencing to ditches to erosion control and livestock water facilities; household programs like low flow toilets; and grade stabilization.

#### **Pecos Watershed Initiative**

Retired New Mexico Bureau of Land Management (BLM) Director **Jesse Juan** and **Norman Vigil** discussed the challenge of landscape-scale conservation when it comes to covering various land ownership statuses such as BLM, Forest Service, Bureau of Reclamation, state and private. **Vigil** described the Pecos Watershed Initiative, which



During the forum, meeting attendees also had the chance to hear from representatives across the conservation delivery partnership.

Department of Interior Deputy Assistant Secretary for Land and Minerals Management **Dr. Andrea Travnicek** (pictured above) discussed the department's relocation of Bureau of Land Management (BLM) headquarters, wildfires and land management, public lands and the ongoing partnership with conservation districts nationwide. Travnicek encouraged district officials to reach out to the agency, saying, "You're involved in the decision making process."



Forum attendees also had the opportunity to hear from Western Landowners Alliance **Executive Director Lesli Allison** (pictured above).

Allison has helped champion the New Mexico House Bill 204, the Healthy Soils Act, and works with private landowners to improve conservation on working lands. Allison has worked throughout her career to champion conservation, implementing progressive conservation management through award-winning programs in restoration forestry, prescribed fire, grazing, stream restoration, hunting and wildlife management, and scientific research and monitoring.

collected data farmer by farmer to determine treatments to regrow grasslands and eradicate invasive species.

#### **Implementing the Alternative Funding Arrangement at the Local Level**

**Marcos Valdez** led the session by discussing the benefits of using the alternative funding agreement (AFA) with NRCS, as well as introducing the RCPP program, which granted \$3.2 million to build resiliency in Rio Chama/San Juan Watershed. Over 19 partners contributed, totaling \$13.4 million. Valdez explained how through match-funding and partnership building, large-scale conservation can be achieved.

#### **Engaging Youth in Urban Agriculture and Environmental Education**

##### **Valencia SWCD's Allison Martin**

led the session by discussing how the district engages local youth by taking them to the Whitfield Wildlife Conservation Area, a 97-acre conservation area, allowing local students to learn about the nature around them. From January-May 2019, over 1,500 students visited from 20 local school grades K-12. "We're trying to enforce using outdoor spaces as classrooms," said Martin.

#### **Urban Ag Demo and Backyard Farms**

##### **Dona Ana SWCD's Jennifer Kleitz and Backyard Farms' Rachel Ryan**

led the session by introducing the urban ag demo program, a result of an NACD Urban Ag Grant, which creates a space for underserved populations to learn how to grow their own food.

#### **Empowering Youth Through Conservation Education and New Mexico Envirothon**

##### **San Juan SWCD's Melissa May and Taos SWCD's Peter Vigil**

led the session by describing how their two districts teach future generations about conservation. Vigil introduced the New Mexico Envirothon and its mission to instill a passion for conservation in young leaders.



The forum concluded with remarks from Natural Resources Conservation Service (NRCS) Chief **Matt Lohr** (pictured). Lohr provided an update on farm bill implementation, discussed why leadership is so important, and applauded the work of the nation's conservation districts day in and day out.

Lohr told attendees "We in conservation have an amazing opportunity to make such a big difference on the people we come in contact with...Our smallest actions can have the biggest impacts."

## NACD BOARD MEETINGS UNITE CONSERVATION LEADERS TO DISCUSS OUTLOOK OF NATIONAL ASSOCIATION



For NACD's Board of Directors, the Summer Conservation Forum and Tour began on Saturday, Aug. 3, with a business meeting. Saturday's meeting began with a New Mexico welcome from the New Mexico state legislature Speaker of the House **Brian Egolf** (pictured).

### Forest Management and Why it is Important

Retired New Mexico State Forester **Anthony Delfin** discussed how forest management impacts communities in many ways, where forests provide water, wood, recreation and habitat for wildlife.

### Woodland Thinning Partners on Private Land

The **East Torrance SWCD's Ken Leiting** discussed the vastness of New Mexico's partnerships due to the numerous land ownership statuses throughout the state. Leiting introduced the Estancia Basin Watershed Health, Restoration and Monitoring Project, which was founded in 2002 and sought to maintain the health and vigor of forests, protect wildlife and improve the productivity and health of the watershed.

### Next Generation Leadership Institute

The Next Generation Leadership Institute (NGLI) is a new program of the National Conservation Foundation (NCF). **Ray Ledgerwood** and **Patricia Lardie** led the session by describing the program and how it prepares conservation leaders to protect the future of our natural resources.

### Sustainable Soil Systems

**Ken and Linda Scheffe** kicked off the session by defining healthy soil as a complex and multifaceted term, that is in a constant state of change. Sustainable soil systems provide ecological function for the whole farm and watershed, where methods include minimizing or eliminating tillage, maintaining ground cover year-round by using cover crops and mulches, and rotational grazing.

### Rainfall Simulator

**Brenda Simpson** utilized a rainfall simulator to demonstrate five soil systems and how they're interrelated, as well as the symbiotic relationship between the plants and the soils. "Soil diversity is inevitable, but you can prepare for it," **Simpson** said.

**NACD President Tim Palmer** discussed NACD's Listening Sessions and encouraged district officials to attend. "Your voice matters," **he said**. "Your feedback helps us as a national association guide our programs and events." NACD has hosted three regional listening sessions, one in Gothenburg, Neb., in June, one in Thackerville, Okla., in July, and a Southwest/Pacific Region Listening Session on Aug. 4 in Santa Fe. NACD will host three additional listening sessions throughout the coming months, concluding in West Virginia in October.

Palmer also encouraged board members to consult [NACD's August Recess Guide to Grassroots Engagement](#) and host congressional representatives in their home conservation districts to learn more about the work they do to improve the local landscape and natural resources.

On Sunday, NACD's Board of Directors heard from a panel on the National Conservation Planning Partnership (NCPP) and a panel featuring the national association's region chairs. The NCPP is made up of NACD, NRCS, the National Conservation District Employees Association (NCDEA), the National Association of State Conservation Agencies (NASCA), and the National Association of Resource Conservation and Development Councils (NARC&DC). The panel described the work of the NCPP to advance conservation planning as a team.







## CARCD Updates

## Website Requirements for Special Districts

A recent change to government code will require all special districts in California to have a website by January 1, 2020. There are still many RCDs that do not yet have a website, and even if yours does it would be a good idea to confirm that it meets all requirements. If you're wondering what needs to be included on a website you can find [a website compliance checklist for special districts at this link](#). Best Best & Krieger also published [a helpful article about the new law](#), including information about a possibility for exemption due to financial hardship.

Recognizing that this new law might pose a burden (financial or otherwise) to some RCDs, CARCD secured funding from a foundation to create a website template in WordPress that our member districts can use as a starting point. This is meant to save RCDs any expense that might be incurred for website design, which can be very costly. The template is scheduled to be ready by September and will include training materials. CARCD staff will also be able to provide some staff support with helping RCDs get their website set up for the first time. The website template will be free for dues paying members, but the RCDs will still need to pay for web hosting through a service provider like GoDaddy. 
