DISTRICTS, PARTNERS GATHER IN TENNESSEE FOR SOUTHEAST REGION MEETING

August 20, 2019



On Aug. 11-13, conservation district officials, employees and partners from 10 southeast states and territories gathered in Gatlinburg, Tenn., for the 2019 NACD Southeast Region Meeting. The three-day meeting was hosted by the **Tennessee Association of Conservation Districts (TACD)**.

On Sunday, Aug. 11, NACD Southeast Region board members met after a morning service. A partnership roundtable followed, led by NACD Southeast Region Chair **Franklin Williams** and Natural Resources Conservation Service (NRCS) State Conservationist for Tennessee, **Sheldon Hightower**. That evening, meeting participants networked and enjoyed a cookout and music from the band **Hillbilly Bad** followed by a private viewing of the film **Hidden Rivers of the Southern Appalachians** with comments from director **Jeremy Monroe**.

On Monday, Aug. 12, NACD Board Member **Ray Weaver** welcomed participants to Tennessee. That morning, conservationist and author **David Ramsey** spoke about the

successful efforts of a diverse group of local citizens to preserve the important Rocky Fork watershed area in eastern Tennessee. Afterwards, TACD President **Jim Bledsoe** addressed participants and Tennessee Commissioner of Agriculture **Dr. Charlie Hatcher** provided a keynote address. Later, at a celebratory luncheon, participants recognized the accomplishments of 10 individuals who were inducted into the Southeast Region Conservation Hall of Fame. After the luncheon, NRCS Deputy Chief for Programs **Jimmy Bramblett** spoke about the implementation of the 2018 Farm Bill and the Conservation Assessment & Ranking Tool (CART) and **Mike Hubbs** spoke about TACD's soil health initiative.



The general session on Tuesday, Aug. 13, opened with an update from NACD Secretary-Treasurer **Ian Cunningham**. NRCS Regional Conservationist for the Southeast **James Tillman** shared information about the Workload Cycle Time Study. Tennessee State Forester and Assistant Commissioner of the Tennessee Department of Agriculture, **David Arnold** talked to participants about the 2016 Sevier wildfires and efforts by local communities to gain and maintain Firewise USA recognition. **Shelby Lyn Sanders** shared the Foothills Land Conservancy's efforts to preserve land in Tennessee. NACD Southeast Region Executive Board Member **Gary Blair** provided closing remarks.

The meeting continued in the afternoon with three different tours. One tour focused on forest management and forest fire recovery, another on land preservation and outdoor learning areas with the **Blount County Soil Conservation District**, and another on the history of Sevier County and the Great Smoky Mountains National Park. The NACD Southeast Region Meeting wrapped up with a banquet and auction benefiting the **Southeast Conservation District Employees Association** accompanied by entertainer **David Browning: The Mayberry Deputy**.

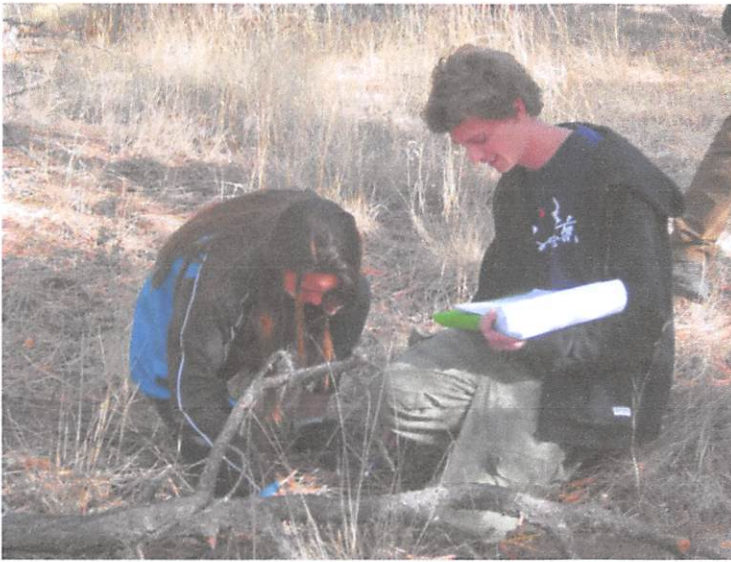

On Thursday, Aug. 15, Field to Market announced the launch of its new project framework called the **Continuous Improvement Accelerator**. The Accelerator is designed to harness the power of collaboration across the agricultural value chain to implement locally-led conservation solutions and



As a single-person, part-time office, the **Grant Soil and Water Conservation District (SWCD)** has its work cut out when it comes to implementing on-the-ground projects, so the SWCD is partnering with The Nature Conservancy (TNC) and the U.S. Forest Service (USFS) to undertake forest restoration in New Mexico.

The timing couldn't be better, as New Mexico's Gila National Forest, which is located in part in Grant County and near the Grant SWCD headquarters in Silver City, has been focusing on restoration efforts to reduce high fuel loads, especially near communities and neighborhoods adjacent to the forest.

"We don't have funding where we can hire a forester or a technician, so it's really important we partner with these outside agencies to help us conduct these projects," Grant SWCD Project Manager **Rebecca Benavidez** said.

"The fires can spread quickly and rapidly, so any time we can do fuels reduction projects it helps the watershed and helps prevent catastrophic fires," **she said**. "We struggle to find funding, so these grants are really important to us."

Grant SWCD was awarded a \$315,000 Collaborative Forest Restoration Program (CFRP) grant from the USFS, which also required a 25 percent or \$80,000 non-federal match. The grant aims to build collaboration and provide treatment to 237 acres of ponderosa pine and pinyon-juniper on the wilderness district of Gila National Forest in southwest New Mexico.

The project takes place in Gattons Park's wildland-urban interface along the edge of a residential area. Objectives include reducing fire risk, harvesting and utilizing small-diameter wood, restoring forest structure, and improving wildlife habitat. Now in its second year, 116 acres have been treated to date, Benavidez said.

"I'm thrilled with what we've been able to accomplish," USFS Gila National Forest Partnership Coordinator **Julia Faith Rivera** said. "We're getting quality work done on the ground and building stronger relationships, not just for this project but for future collaboration efforts as well."

TNC initially applied for and received a CFRP grant for planning the project. In 2018, the Grant SWCD was awarded the implementation grant. TNC assisted with completion of the archaeological and environmental analysis in the first CFRP grant and currently continues the project monitoring component in the second CFRP.

This list isn't exhaustive, but we hope that it helps paint a picture of some of the exciting work that we're doing every day on behalf of your districts.

California Agricultural Partnership Forum

CARCD has been part of the California Agricultural Partnership Forum working group, which includes the California State Water Resources Control Board, USDA NRCS, and Cal EPA. The group meets with the goal of streamlining permitting and promoting watershed pilot projects focused on enhancing watershed functions. Reducing permitting load is crucial for effective watershed conservation efforts going into the future.

Salmonid Recovery with Department of Fish and Wildlife

CARCD joined the California Department of Fish and Wildlife's working group on North Coast salmonid recovery which includes other non-profit organizations and CDFW staff. The group is working on a new assessment that

incorporates information on local activity such as landowner participation and active conservation organizations.

Advocacy at the Capitol

The next legislative session is approaching, and CARCD and Pacific Policy Group have been preparing for funding and other legislative asks. As CARCD and RCDs have been gaining recognition at the Capitol, we are better positioned to cultivate partnerships and write RCDs into bills to gain new funding opportunities.

Meeting with Wade Crowfoot

Wade Crowfoot, the new Secretary of Natural Resources, met with our Executive Director, Karen Buhr, for the first time to talk about the role of RCDs and the nature of funding for RCDs. Secretary Crowfoot recognizes the value of RCDs and we look forward to working with him to enhance our partnership with the California Natural Resources Agency.

Bechtel Funded Diversity, Equity and Inclusion Training

CARCD has been engaged in a Diversity, Equity, and Inclusion (DEI) deep dive training funded by the Bechtel foundation. Participants are environmental leaders from across the state. Karen Buhr completed three trainings of 3-5 days and presented the core lessons to the CARCD board. Along with CARCD, Peter Braudrick of the Mendocino RCD and Sheryl Landrum from the RCD of Greater San Diego also participated.

SB 253 Testimony and Hearings

SB 253, the bill to create the Environmental Farming Incentive Program, is co-sponsored by CARCD and The Nature Conservancy. We have been working to finalize language in an amendment to explicitly include RCDs as the primary technical service providers. It still needs to get through appropriations, and needs the governor's signature, but at this point is very promising.

Sierra Nevada Conservancy

We have been building our ongoing partnership with the Sierra Nevada Conservancy. In July, we met with their executive officer, Angela Avery, to see how RCDs and SNC can better partner together. The Conservancy is an important source of funding and support for RCDs, and we actively maintain the relationship.

Division 9 Revisions

CARCD has convened a committee to draft proposals for Division 9 revisions which would best serve the interests of RCDs. We have been working closely with the Department of Conservation and with RCD District Managers and board members from across the state representing a diversity of regions and capacities. The RCD Division 9 committee had a group phone call in July to bring together findings and suggestions from three sub-committees.

Xerces Society Collaboration

The Xerces Society and CARCD have been in conversation about how we can collaborate on monarch restoration projects. The most recent conversation was about partnering around the National Fish and Wildlife Foundation's Monarch Butterfly and Pollinators Conservation Fund proposal that CARCD submitted on behalf of RCDs.

Durable Collaborations

Over the past few years, CARCD has secured state and private funding to support six RCD durable collaboration explorations throughout the state. With the guidance of CARCD and Solid Ground Consulting, the North Coast cohort has been working together since 2016 to outline their goals and create a clear path forward to achieve their objective of being able to contract as region with state and federal funding partners. In July, CARCD staff co-facilitated a call with the North Coast durable collaboration cohort.

Healthy Soils at the Governors Office

Multiple NGO groups including CARCD are working with administration at the Governor's Office to talk about needs and goals for California to achieve carbon neutrality. We are excited to enhance RCD's visibility as crucial partners to help the state enact healthy soils and carbon neutrality programs.

Landscape Stewardship Network

CARCD has been maintaining and strengthening its partnership with the Landscape Stewardship Network and met with its executive director, Sharon Farrell, to discuss how to better partner with each other.

California Farm Demonstration Network

In May of 2017, CARCD, NRCS, CA Farm Bureau Federation, CDFA, UC Davis, and the UC Division of Agriculture and Natural Resources signed an MOU to form [the California Farm Demonstration Network \(CFDN\)](#). CARCD's role within the MOU signing partners is to organize and house the administrative services of CFDN. This July, 40 partners participated in a meeting to discuss tangible next steps of building the network.

Racial Equity Webinar

As part of an effort to educate ourselves on diversity and equity, one of our staff attended a webinar on "Measuring Racial Equity in the Food System". The webinar looked at research-based findings on inequity in the food system, which will help inform CARCD on how we can be a part of increasing equity in our communities.

Public Comment at CDFA Meeting

CARCD staff attended the CDFA's Environmental Farming Act Science Advisory Panel meeting and provided comment on their Climate Smart Agriculture Program. This is an important source of funding for RCDs, and we brought up concerns voiced by RCDs which we had collected earlier.

Comment Letter to State Coastal Conservancy

On behalf of RCD interests, CARCD submitted a comment letter to the State Coastal Conservancy about their Prop 68 SF Bay Climate Funds. We hope the comments will make the program more accessible and effective for RCDs.

Collaboration Meeting

CARCD is partnering more closely with the core partners in the carbon and agricultural space. California Climate and Agriculture Network, Carbon Cycle Institute, American Farmland Trust, Community Alliance with Family Farmers, and CARCD are now meeting on a regular basis to align on critical shared goals and had its third meeting in July.

CARCD Updates

Soil Health Terrace

Website Requirements for Special Districts

A recent change to government code will require all special districts in California to have a website by January 1, 2020. There are still many RCDs that do not yet have a website, and even if yours does it would be a good idea to confirm that it meets all requirements. If you're wondering what needs to be included on a website you can find [a website compliance checklist for special districts at this link](#). Best Best & Krieger also published [a helpful article about the new law](#), including information about a possibility for exemption due to financial hardship.

Recognizing that this new law might pose a burden (financial or otherwise) to some RCDs, CARCD secured funding from a foundation to create a website template in WordPress that our member districts can use as a starting point. This is meant to save RCDs any expense that might be incurred for website design, which can be very costly. The template is scheduled to be ready by September and will include training materials. CARCD staff will also be able to provide some staff support with helping RCDs get their website set up for the first time. The website template will be free for dues paying members, but the RCDs will still need to pay for web hosting through a service provider like GoDaddy. USDA Specialty Crop Research Initiative

The purpose of the USDA's [Specialty Crop Research Initiative Program](#) is to address the critical needs of the specialty crop industry by awarding grants to support research and extension that address key challenges of national, regional, and multi-state importance in sustaining all components of food and agriculture, including conventional and organic food production systems. The closing date is October 15. Funding is primarily for universities and 501c3 non-profits, and does not include special districts. The National Fish and Wildlife Foundation is soliciting proposals to plan and implement fuels management projects on National Forest System lands within California. The goal of [the Pacific Southwest Fuels Management Strategic Investments Partnership](#) is to identify and fund fuel management projects that reduce the risk of severe wildfire, protect ecological values of USFS restoration investments, and reduce the risk of damage to public and private improvements near USFS lands. 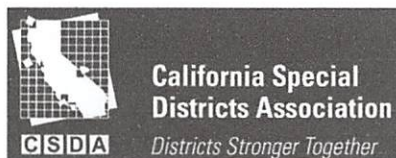

At the end of the **Conservation Districts of Iowa (CDI)** meeting, NACD held the North Central Region Listening Session. This session is one of six scheduled across the country to offer an opportunity for NACD leadership to connect with members.

The **Conservation Districts of Iowa** (CDI) held its annual meeting in Ames, Iowa, from Aug. 19 – 20, where district officials, employees, commissioners and conservation partners gathered to discuss current issues, programs and policy, as well as elect their new state leadership.

The conference theme, "**Life in the Soil: Dig Deeper**," was carried throughout the program with panel discussions from conservation partners and state leadership, breakout sessions and networking with a variety of exhibitors from the conservation industry, as well as partnering organizations and agencies.

NACD North Central Region Representative **Beth Mason** led a breakout session, "NACD Soil Health Champions Network: Advancing Soil Health," which introduced the network to a broad audience of Iowa conservationists and showcased three operations managed by Soil Health Champions in Iowa – **Dennis Carney** of Mason City, **Don Elsbernd** of Postville and **Jack Boyer** of Reinbeck.

Each Champion shared how his operation has incorporated and prioritized soil health and some of the lessons learned over the years.

MARYLAND DISTRICT DEMONSTRATES PLANTING GREEN

On Tuesday, Aug. 20, Delaware's **Sussex Conservation District** held its annual Soil Health Field Day. This year, the theme was "Planting Green."

Hosted at NACD Soil Health

Champion **Chip Baker's** farm, approximately 100 people gathered to learn about how to manage fields to boost organic matter and weed suppression.

The day began with a short presentation from **Chris Brosch**, the Nutrient Management Plan Program Administrator for the Delaware Department of Agriculture.

Brosch discussed three parts of Delaware's upcoming version of the Nutrient Management Plan – increasing conservation tillage to 90 percent, more than doubling cover crop acres, and enhancing nutrient management.

Speaking about cover crops, **he said**, "Not only are they good for improving the water quality of the Chesapeake Bay, but they also give farmers a great return on investment."

FARM BILL LISTENING SESSION



As part of efforts to bring together several key players in the implementation of the 2018 Farm Bill and in conjunction with NACD's push for grassroots engagement over the August Congressional recess, **NACD First Vice President Michael Crowder** hosted a Farm Bill Listening Session at Barker Ranch on Aug. 21, 2019.

The event featured a panel of policymakers and USDA agency representatives, followed by a question and answer session for attendees to learn more about USDA activities and implementation of the farm bill.

As second in the nation in number of crops produced, Washington State's diverse agricultural and forestry industries enable multiple partners to meet the needs of producers. The panel members highlighted these successful partnerships, while also discussing the benefits of the new farm bill.

Natural Resources Conservation Service (NRCS) Associate Chief **Kevin Norton** stressed that a reduction in paperwork will ensure conservation is on the ground faster and Washington NRCS State Conservationist **Roylene Comes at Night** noted the value of NRCS' local working groups.

The question and answer session allowed attendees to learn more about the changes in the farm bill and USDA programs, including USDA staffing strategies, provisions in the farm bill related to drought and water conservation, and modifications to the Conservation Reserve Program (CRP).

Norton also discussed the number of farm bill programs available to beginning farmers and ranchers and other underserved groups. NACD Board Member **Doug Rushton** was also present at the event and stated the panel members brought a lot of

Cumberland County Soil and Water Conservation District (SWCD).

NACD's Northeast Region Representative **Eric Hansen** presented an overview of NACD's programs. Attendees also heard from the Maine state champion Envirothon team from **Spruce Mountain High School** in Jay, Maine.

In conjunction with the summer meeting, the **Cumberland County SWCD** recently purchased its office building and hosted a celebratory open house.

LEADERS GATHER IN IOWA FOR CONSERVATION TOUR

The Conservation Technology and Information Center (CTIC) Conservation in Action Tour was held in central Iowa, Aug. 20 – 21, which brought together industry leaders alongside conservation partners from nonprofit organizations and government agencies to explore conservation efforts in Iowa.

Much of the tour centered around Iowa's Nutrient Reduction Strategy and edge-of-field conservation systems such as bioreactors and saturated buffers.

One of the tour stops was in Nevada, Iowa, at the Couser Cattle Company, an operation that continues to experiment with conservation practices on both the cattle operation and its crop side of the business. As a vehicle for community outreach, the Cousers are developing a 220-acre AGvocation Learning Farm, which will be a site for research and demonstration trials.

The tour also included a visit to the Iowa Land Improvement Contractors Association (LICA) Farm in Melbourne, Iowa. This 80-acre farm was purchased by LICA in 2003 as a demonstration farm, providing association members a place to construct a wide range of conservation systems, which help farmers trap nutrients from flowing off-site.

NACD **President** and CTIC board member **Tim Palmer** served as co-chair for the tour where Iowa is his home state. Additionally, NACD Director of Development **Laura Demmel**, North Central Region Representative **Beth Mason** and many conservation district employees and commissioners throughout Iowa were in attendance.

The event provided all attendees both valuable demonstrations of conservation practices at work, as well as valuable networking time with conservation leaders from across the country.

SEPTEMBER U&C WEBINAR FOCUSES ON ENGAGING GOVERNMENT SUPPORT

Dear Colleagues,

We are thrilled to announce that the Wildlife Conservation Board (WCB) voted to fund the CARCD block grant application for the Monarch Butterfly and Pollinator Rescue Program. The grant was awarded the maximum amount of \$750,000 for CARCD to administer block grants to fund individual RCD projects to implement habitat restoration, overwintering site enhancement, and provide education and outreach to local communities.

This is a huge step in expanding the great work that the RCDs are doing to support pollinators in California. We are grateful to the RCD staff who provided expertise and advice on the full application and shared pictures of past pollinator projects.

As our first step in implementing the program, CARCD will convene a Technical Advisory Committee comprised of NRCS, the Xerces Society, Environmental Defense Fund, and others to map out where implementation and technical assistance projects will have the greatest positive impact on the migrating monarch populations. Please know that we will do our best to fund as many RCD projects as possible under this block grant program, but the final decisions about sub-contracts will be up to the WCB Program Manager.

Website Requirements for Special Districts

A recent change to government code will require all special districts in California to have a website by January 1, 2020. There are still many RCDs that do not yet have a website, and even if yours does it would be a good idea to confirm that it meets all requirements. If you're wondering what needs to be included on a website you can find [a website compliance checklist for special districts at this link](#). Best Best & Krieger also published [a helpful article about the new law](#), including information about a possibility for exemption due to financial hardship.

Recognizing that this new law might pose a burden (financial or otherwise) to some RCDs, CARCD secured funding from a foundation to create a website template in WordPress that our member districts can use as a starting point. This is meant to save RCDs any expense that might be incurred for website design, which can be very costly. The template is scheduled to be ready by September and will include training materials. CARCD staff will also be able to provide some staff support with helping RCDs get their website set up for the first time. The website template will be free for dues paying members, but the RCDs will still need to pay for web hosting through a service provider like GoDaddy. 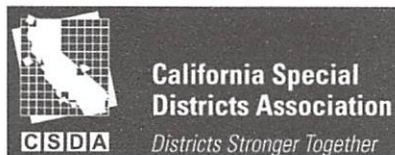

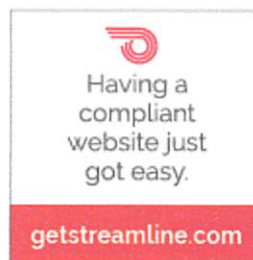
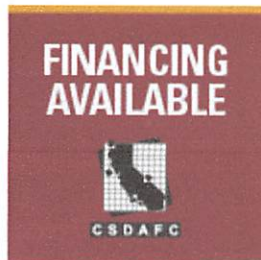

Beehler and BCMBCB collaborate closely with **NACD First Vice President Michael Crowder** in mosquito management at Barker Ranch, where Crowder serves as the general manager.

Peters and Rivers also presented on NACD and various conservation tools used at Barker Ranch for mitigating mosquitoes and other pests while providing habitat for wildlife.

Many presenters in the AGRO sections discussed conservation as a method for mitigating or offsetting effects of pesticide use and the interactions between the Endangered Species Act (ESA) and the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA).

Additionally, presenters provided information on water scarcity, including updates on the recent California drought, biostimulants as defined by the 2018 Farm Bill and their potential use in sustainable agriculture, and the economics of integrated pest management.

On Tuesday night, Peters and Rivers represented NACD at an outreach event, where they shared information on members' work across the nation. The meeting served as a productive introduction of NACD to a variety of new and potential partners.

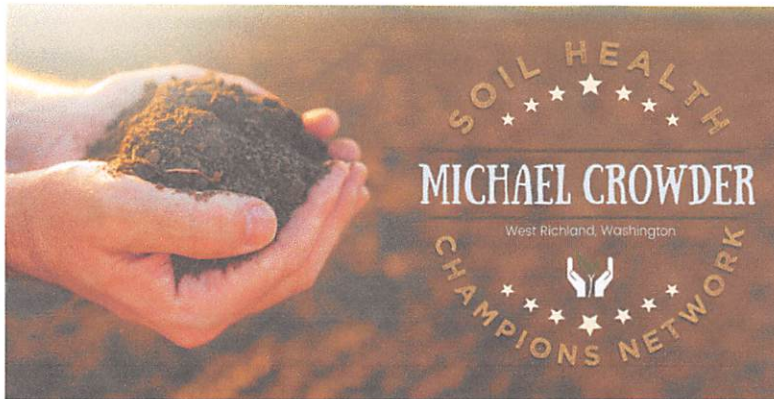

as one of the association's Soil Health Champions in Washington State. With his Midwestern roots, Crowder manages farm operations in both Illinois and Washington, and serves as a partner at his third-generation family farm in Indiana.



In 2001, Crowder became general manager of Barker Ranch in West Richland, Wash., and in 2013, he became a full shareholder of the 2,000-acre ranch where he lives with his wife Gretchen.

Barker Ranch is a unique property with the majority of the property enrolled in the Natural Resources Conservation Service (NRCS) Wetland Reserve Program (WRP) easement, which aims to ensure year-round habitat for migratory waterfowl like ducks, geese and sandhill cranes. Barker Ranch incorporates both flash grazing of cattle and no-till practices in wildlife food plots for soil health and vegetative management.

With his ranch receiving an average annual rainfall of six to eight inches, Crowder is constantly monitoring the soil moisture and irrigation to gauge what it needs to produce higher yields and be more efficient with the moisture that exists in non-irrigated acres.

In their conservation efforts to provide habitat for migratory waterfowl, Crowder and his partners on Barker Ranch conduct outreach with many groups, engaging them in various activities on the ranch. As NACD First Vice President, Crowder has been able to take his message of soil health to a national level.



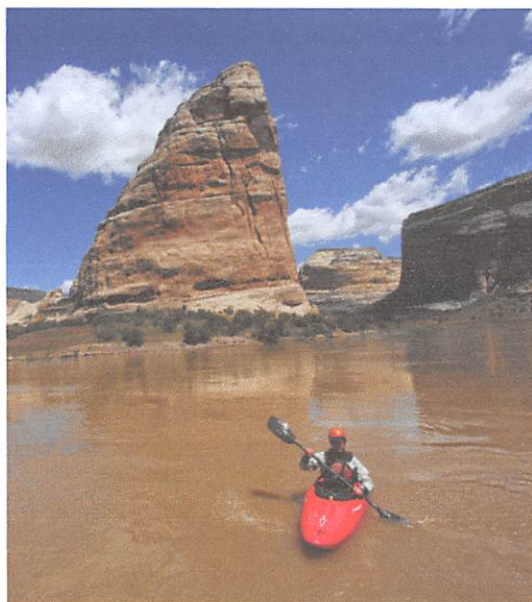

You have requested that we perform a review engagement with respect to the financial statements of Temecula-Elsinore-Anza-Murrieta Resource Conservation District (District), which comprise the statement of net position as of June 30, 2019, and the related statement of activities for the year then ended, and the related notes to the financial statements. In addition, the budgetary comparison schedule – general fund will be presented with the financial statements. Such supplementary information is the responsibility of management, but will be subjected to the review procedures applied in our review of the basic financial statements.

Our Responsibilities

If, for any reason, we are unable to complete the review of your financial statements, we will not issue a report on such statements as a result of this engagement.

You agree to include our accountant's review report in any document containing financial statements that indicates that such financial statements have been reviewed by us and, prior to inclusion of the report, to obtain our permission to do so.


Engagement Administration, Fees, and Other

We will schedule the engagement based in part on deadlines, working conditions, and the availability of your key personnel. We will plan the engagement based on the assumption that your personnel will cooperate and provide assistance by performing tasks such as preparing requested schedule and retrieving supporting documents. If, for whatever reason, your personnel are unavailable to provide the necessary assistance in a timely manner, it may substantially increase the work we have to do to complete the engagement within the established deadlines, resulting in an increase in fees over our original fee estimate.

We will provide copies of our reports to the board of directors; however, management is responsible for distribution of the reports and the financial statements.

The review documentation for this engagement will be retained for a minimum of seven years after the report release date.

We expect to begin our review in June 2019 and to issue our reports no later than September 30, 2019. Paul J. Kaymark, CPA is the engagement partner and is responsible for supervising the engagement and signing the report or authorizing another individual to sign it.



The maximum fee for our services under the terms of this agreement shall be \$1,750. Preparation of the Annual State Controller's Report shall be \$250.

Our invoices for these fees will be rendered each month as work progresses and are payable on presentation. In accordance with our firm policies, work may be suspended if your account becomes 90 days or more overdue and may not be resumed until your account is paid in full. If we elect to terminate our services for nonpayment, our engagement will be deemed to have been completed upon written notification of termination, even if we have not completed our report. You will be obligated to compensate us for all time expended and to reimburse us for all out-of-pocket costs through the date of termination. The above fee is based on anticipated cooperation from your personnel and the assumption that unexpected circumstances will not be encountered during the audit. If significant additional time is necessary, we will discuss it with you and arrive at a new fee estimate before we incur the additional costs.



Such arbitration shall be binding and final. IN AGREEING TO ARBITRATION, WE BOTH ACKNOWLEDGE THAT IN THE EVENT OF A DISPUTE OVER FEES CHARGED BY THE ACCOUNTANT, EACH OF US IS GIVING UP THE RIGHT TO HAVE THE DISPUTE DECIDED IN A COURT OF LAW BEFORE A JUDGE OR JURY AND INSTEAD WE ARE ACCEPTING THE USE OF ARBITRATION FOR RESOLUTION. The prevailing party shall be entitled to an award of reasonable attorneys' fees and costs incurred in connection with the arbitration of the dispute in an amount to be determined by the arbitrator.

Dear Mr. Flodine,

We are in receipt of your most recent e-mail as to the inquiry regarding a check that was written in 2007 by TeraCor Resource Management for \$56,000.00 and the work that was done for those funds. As I understand, the monies were used for invasive removal and habitat restoration and all monies have been appropriately spent to address the requirements by California Department of Fish and Wildlife and therefore no monies are due.

It is our understanding the McCall 71 LLC (Sam Yoo) sold the property and that individual or company sold it to you in 2014. We assume that your group is developing this property. If we are correct in this assumption, the additional monies you paid to Riverside-Corona RCD, is more than likely for new issues or requirements that CDFW or Army Corps are now requiring to be met. As I am sure you are aware, many of the regulations have changed over the years, not to mention that this particular project was addressed over 12 years ago. Therefore, any new regulations that would need to be met or mitigation that has to be done at this point would be additional. This is something you would have to take that up with CDFW and/or RCRC. The statute of limitations has been passed many years ago and our work was completed.

I hope this helps you. It might be best to contact CDFW to ascertain more information but at this time, we no longer have any obligations to fulfill in this matter.

TERACOR Resource Management (TERACOR) initially submitted a non-jurisdictional determination (NJD) for the above referenced property on 31 May 2006. You agreed the feature on-site was not jurisdictional but recognized, nonetheless, that the feature exhibited limited biological resource values. You subsequently required TERACOR to submit a SAA and a fee of \$200 in order to assign the property and related project a file number for tracking purposes.

Additionally, you asked that TERACOR conduct a focused Burrowing Owl (BUOW) Survey to determine whether BUOW occupied or utilized the site or immediate surrounding areas. This survey was completed in August 2006 and the results were negative for BUOW (see report enclosed).

TERACOR submitted the SAA and \$200 fee on 06 November 2006. CDFG responded with an Operation of Law letter dated 18 December 2006 which stated, "As a result, by law, you may now complete the project described in your notification without an agreement." As part of the project, McCall 71, LLC voluntarily mitigated for the loss of limited biological resource values through the Elsinore-Murrieta-Anza Resource Conservation District.

We are providing to you a check for the Elsinore-Murrieta-Anza Resource Conservation District in the amount of \$56,000.00. This concludes McCall 71, LLC's consultation with CDFG.

Gentlemen,

I attended a meeting with the City of Lake Elsinore yesterday in order to discuss how we could be of assistance as TEAM RCD in sharing our reports on our homeless monitoring program with the Flood Control projects we are currently working on. We were asking for collaboration and assistance in those areas (Helash, Tualata Creek etc) in which we are working on projects for Flood Control and in which they have jurisdiction to assist in moving the Homeless out so that we may eventually be able to start restoration projects. Sergeant Warrington is in charge of the task force for Lake Elsinore but he is also willing to assist us in the flood control projects which reflect homeless activity that are in the unincorporated areas near there such as Wildomar, etc. Those projects specifically at this time would be Tualata Creek and Helash for now but he mentioned other areas that are Flood Control areas that Homeless are encamping that might not be on our list of projects with Flood. I asked him to get me a list of those locations so that we may take a look at them as potential sites to address.

During the discussion, Sergeant Warrington mentioned that they are having a major challenge in one channel where the Homeless are jumping the fence when the sheriffs are in pursuit but they were hampered by a locked Flood Control gate. Which obviously means the officers have to jump the gate too. I will get you the exact location later or perhaps Sergeant Warrington can let you know through e-mail. They would like to have a key to the Flood Control gates, and I am asking on their behalf if this could please be done in order to make these pursuits safer for the officers and easier for them to access Flood Control channels in order to monitor and hopefully prevent further homeless encampments from taking a foothold. I spoke with Mr. Uhley this morning and he feels this is possible. Can we see how quickly we can get the Sergeant a key to the gates and what the process would be?

Thank you for working so closely with us on this project. We feel this will help Sergeant Warrington and his team more effectively clear our watersheds by having easier access to deter the homeless, criminal activity etc. but the debris and trash they leave behind which affects us all.

Ladies and Gentlemen,

We at the Temecula-Elsinore, Anza-Murrieta Resource Conservation District recently instituted a Bi-Monthly Homeless Monitoring program in collaboration with Riverside County Flood Control to monitor for homelessness on specific projects we are currently working on with them to manage the vegetation in the “no go zones” of the watersheds. We are getting this accomplished with the help and partnership we have with the Santa Ana Watershed Association in order to accountably manage areas that are sensitive to habitat creation and/or conservation. In particular we are monitoring as well for the potential habitat destruction by intrusion by the homeless population, thus the adoption of our habitat/homeless monitoring pilot program.

Attached you will find our most recent reports which we will be forwarding on a monthly basis to you so that we can more cohesively attack this issue within our District borders. If we can identify the problems within your City and bring attention to each City's Homeless Task Forces those homeless groups congregating within certain areas when they are in smaller numbers, we may be able to help address several issues at once before they become bigger and larger issues.

As we have begun to see in cities as large as Los Angeles and San Francisco, the homeless issue is rapidly becoming a health issue as well and we are determined to do our best to be part of the solution. As we have said before to many of you that we have met, we do not have the authority to remove either homeless, their belongings or any HazMat type material that may be within the watersheds. However, we do have the ability to work in areas once removal of both homeless and hazardous materials has occurred, and restore the area to what it once was for wildlife and habitat.

At our most recent meeting, we assigned one of our Associate Directors, Newt Parkes, to follow up monthly with Task Forces in each city where we have a project in which we are working with Riverside County Flood Control. Newt will be reaching out to each City and its Task Force to continue to keep them informed of encampments in their area that need addressing. We also will copy Riverside County Flood Control to keep them in the loop in order to have them be aware of where their help is needed and required by some of their existing contracts with particular cities.

We recognize this is only a small solution to part of the overall problem of Homelessness that needs to be addressed. But TEAM RCD feels that it is a start to perhaps a long term approach that might eventually involve not just our RCD but the many throughout our state and our Nation that are struggling with the same problem. Trying to balance and protect our conservation areas, keep our water quality clean, help our cities and still help in the fight to help those caught up in the plight of homelessness is not an easy task. It is a big ask. But we feel that we and our City and County officials are up to it.

I got your email and voicemail. I'll call you in a few minutes. Murrieta would be happy to help with enforcement on any property within our borders where we have a 602-No Trespassing letter on file. Fortunately, RivCo Flood Control has issued a 602 letter, and we actively monitor Murrieta Creek and other Flood Control properties. However, none of the sites on your attachment fall within Murrieta, so we are limited to what we can do outside of our jurisdiction. Here are the locations with potential contacts:

1. Helash encampment – this area is located within the City of Wildomar. Potential contact: Felicia Folmar, ffolmar@cityofwildomar.org.
2. Tualota Creek 1, 2 & 3 – this area is located within the unincorporated Riverside County. I believe the contact is County Code Enforcement, but I am not sure of that. We have passed on information about the various encampments in this area to a number of County agencies in the past, as these encampments impact both Murrieta and Temecula.

I don't want to sound like we do not want to help. I appreciate these reports, and if the County asks for assistance, we'd certainly do what we can to help. But I cannot send my officers into these encampments when they are located outside of our City limits.

I'll give you a call so we can discuss further.

Ladies and Gentlemen,

We at the Temecula-Elsinore, Anza-Murrieta Resource Conservation District recently instituted a Bi-Monthly Homeless Monitoring program in collaboration with Riverside County Flood Control to monitor for homelessness on specific projects we are currently working on with them to manage the vegetation in the "no go zones" of the watersheds. We are getting this accomplished with the help and partnership we have with the Santa Ana Watershed Association in order to accountably manage areas that are sensitive to habitat creation and/or conservation. In particular we are monitoring as well for the potential habitat destruction by intrusion by the homeless population, thus the adoption of our habitat/homeless monitoring pilot program.

REPORT AREA II: DESCRIPTION OF THE HABITAT RESTORATION, ENHANCEMENT, AND CONSERVATION ACTIVITIES PERFORMED WITHIN EACH PROJECT AREA

Current site conditions: Encampments are currently active on Helash, Tualota Creek 1 & 2, and Tualota Creek III. At Helash, there are multiple tents set up on the northern end of the project with multiple transients living in those tents. At Tualota Creek 1 & 2, there is one tent underneath the bridge between the two projects with 2 transients. At Tualota Creek III there is currently one tent alongside the creek bed with 1 transient. Points were used to mark the locations of transients within project boundaries with photos on each point.

Enhancement Activities: SAWA recommends trash and waste removal on all Team RCD projects in the future following transient removal.

The frequency and timing transient monitoring: Monitoring occurred bi-weekly to current, starting from January 16th, 2019.

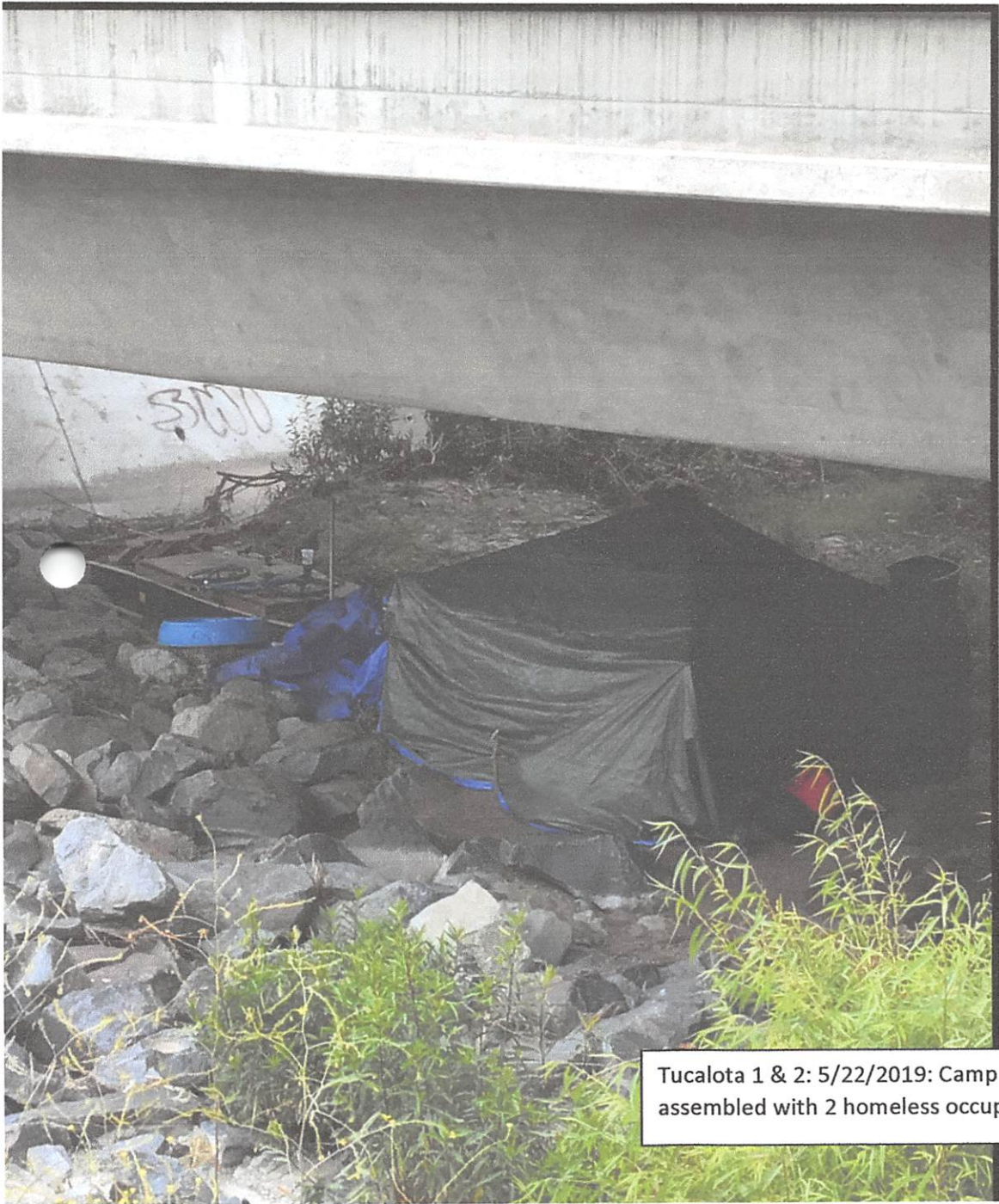

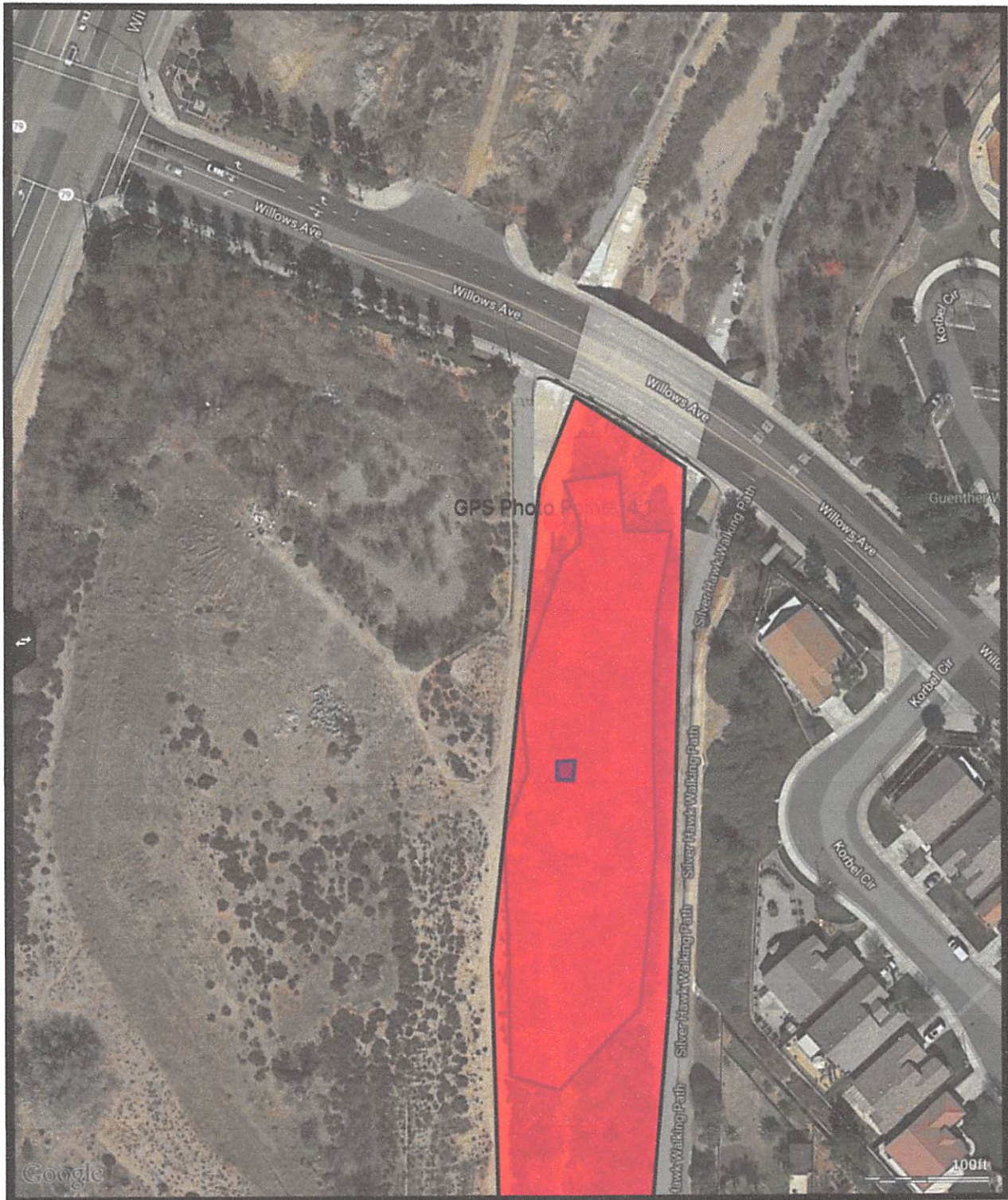

**MAINTENANCE SERVICES AGREEMENT
BETWEEN THE TEMECULA-ELSINORE-ANZA-
MURRIETA RESOURCE CONSERVATION
DISTRICT AND THE FAIRWAY ESTATES
HOMEOWNERS ASSOCIATION**

This Maintenance Services Agreement ("Agreement") is entered into this 6th day of September, 2019, by and between the Fairway Estates Homeowners Association, a California nonprofit mutual benefit corporation ("Association") and the Temecula-Elsinore-Anza Murrieta Resource Conservation District, a California Resource Conservation District and governmental Special District ("TEAM RCD") (collectively, the "Parties").

RECITALS

WHEREAS, pursuant to California Public Resources Code section 9412, the California Legislature has granted TEAM RCD authority to provide technical assistance to private landowners within the district to support practices that minimize soil and related resource degradation, provided, however, that the Association agrees to use such assistance on its lands within the district in furtherance of TEAM RCD's objectives, plans and regulations.

AGREEMENT

NOW, therefore, in consideration of the above and the mutual covenants, terms and conditions contained herein, and pursuant to the laws of the State of California, the Association and TEAM RCD hereby agree as follows:

1. **Activities:** Upon timely payment of the "Maintenance Fee" described below, TEAM RCD agrees to perform maintenance services in the Non-Conservation Easement Areas as further described in Exhibit "A" ("the Activities") and within the areas shown in Exhibit "B."

2. **Access:** The Association grants access to TEAM RCD in order to carry out the Activities described in this Agreement. If the Association, any homeowner in the Project area or subsequent owner of the Project, the Association, or their successors in interest interfere with TEAM RCD's reasonable access to conduct the Activities, TEAM RCD's duties and responsibilities under this Agreement shall be suspended until such access is restored.

3. **Funding of Actual Costs:**

a. The Association shall pay TEAM RCD the sum of \$6,091.04 (SIX THOUSAND NINETY ONE DOLLARS AND FOUR CENTS) ("Maintenance Fee"), upon the execution of this Agreement.

b. The Parties agree that the Maintenance Fee is a reasonable amount calculated to cover the anticipated costs of the Activities. If the actual costs (including without limitation, administrative staff time, overhead and related legal costs) exceed the anticipated costs, TEAM RCD shall bill the difference to the Association.

4. **TEAM RCD's Streambed Alteration Agreement:** TEAM RCD is permitted through the California Department of Fish and Wildlife to conduct the Activities pursuant to its Streambed Alteration Agreement (Notification No. 1600-2012-0014R6("1600 Permit") The 1600 permit is non-transferable and will not be available for use for the Activities when this Agreement is terminated. In the event any changes are required to the 1600 Permit that may affect the performance of the Activities by TEAM RCD, the Parties will meet and confer to amend the Activities accordingly.

5. **Liabilities/Indemnity:** The Parties agree that TEAM RCD shall have no duty or responsibility for the protection of individual homeowners within the Project, the Association, its invitees, agents, contractors, consultants, heirs, estates, successors, assigns and /or subsequent homeowners, the public, or any third parties from risks relating to conditions in the Non-Conservation Easement Areas, except to the extent of the negligence or willful misconduct of TEAM RCD, its employees, or subcontractors while present on the Non-Conservation Easement Area. As such, the Association shall indemnify and hold TEAM RCD, its officers, agents, or employees free and harmless from liability to any person or entity not a Party to this Agreement from any damage, loss or injury to person and/or property, except to the extent of the negligence or willful misconduct of TEAM RCD, its employees, or subcontractors while present on the Non-Conservation Easement Area.

6. **Insurance:** Each Party to this Agreement shall, at its sole cost and expense, procure and maintain during the term of this Agreement the following insurance coverage: (i) worker' compensation insurance required under state law, and (ii) a policy of general liability insurance written by one or more responsible insurance carrier(s) insuring against liability for injury to persons and/or property and death of any person or persons occurring in, on or about the Non-Conservation Easement Areas arising from the Parties, their agents, consultants and subcontractors, with a liability limit under such insurance of not less than \$2,000,000.00 for any one accident and death or injury of any one person and not less than \$2,000,000.00 for any one accident and \$500,000.00 for property damage. Each Party shall name the other as Additional Insureds on the respective policies and shall furnish the other with certificates of insurance issued by the appropriate insurance carrier(s) evidencing compliance with the terms of this Section and providing that such insurance shall not be canceled except after thirty (30) days written notice to the other Party.

7. **Transferability; Right to Enforcement:** The Agreement is non-transferable. The Association's right to enforce the terms of this Agreement shall not be assigned, conveyed, or otherwise transferred, by contract, agreement or by operation of law, to any successor or any other person or entity without TEAM RCD's express written agreement. TEAM RCD's agreement to such transfer may be contingent upon amendment of this Agreement. Under no circumstance shall any individual homeowner within the Project area have any enforcement rights under this Agreement as against TEAM RCD.

8. **Time of Performance:** TEAM RCD agrees to begin performing the Activities no later than fourteen (14) days aft the receipt of the Maintenance Fee and the clearance of all funds from issuing bank to the TEAM RCD bank account.

9. **Cancellation:** Either Party may cancel this Agreement at any time upon thirty (30) days' written notice by so notifying the other Party by certified mail. If this Agreement is properly cancelled, TEAM RCD shall withhold all costs and expenses incurred through that date from the amount paid to TEAM RCD pursuant to sections 3 or 4 and refund the balance to the Association within thirty (30) days' request therfor.

10. **Notices:** Any notice, demand, request, consent, approval, or communication that either Party desires or is required to give to the other shall be in writing and either served personally or sent by first class mail, postage prepaid, addressed as follows:

11. **Controlling Law Venue:** The interpretation and performance of this Agreement shall b governed by the laws of the State of California. The Parties expressly accepts the jurisdiction and venue of the Riverside County Superior Court in any litigation brought to enforce or interpret this Agreement.

12. **Entire Agreement:** This instrument, including exhibits, sets forth the entire agreement of the Parties with respect to the Activities and supersedes all prior discussions, negotiations, understandings, or agreements relating to the Activities, all of which are merged herein.

13. **Amendment:** This agreement shall not be changed, modified or amended except upon the written consent of the Parties hereto.

14. **Attorneys' Fees:** The prevailing Party in any litigation brought to enforce or interpret this Agreement shall be entitled to recover its attorneys' fees and all costs of litigation including but not limited to, expert witness fees, in addition to any other relief to which it may be entitled. Fees and costs not included within those allowed by Code of Civil Procedure 1033.5 shall be set forth in the Parties' pleadings and shall be proved in a bifurcated trial before the trial judge alone, the right to trial by jury being hereby waived, after the conclusion of the trial on all other issues.

15. **Authority:** Each Party to this Agreement warrants to the other that it is duly organized and existing and that it and the respective signatories have full right and authority to enter into and consummate this Agreement and all related documents and bind the parties thereto.

EXHIBIT A

Description of Activities:

TEAM RCD will perform two days of non-native species control within the area identified in Exhibit B of this agreement, to consist of one or more of the following activities:

- Non-Native species removal and limbing of native horizontally growing vegetation up to 4 feet. Species to include but not limited to: Pampas grass, palm trees, and tamarisk
- Treatment of the large palm at the top of channel
- Clearing of an area five feet wide along the channel from the golf course to Cherrywood Drive exclusive and in avoidance of existing and predetermined habitat areas.

The Parties agree that:

- TEAM RCD staff will have the discretion to select best methods for non-native control and to determine order of treatments for target species within the area shown as Exhibit B. Non-native removals in excess of funding provided for 2019-20 work will be documented and scheduled for 2020-21 treatments.
- A Green Climber from TEAM RCD will grind all debris generated on site from removal activities and Fairway Estates will not be responsible for any debris removal and disposal of bio-mass and invasive materials generated from the project.
