Public comment: Dir. Rahn invited Dr. Larom and Eric Humel to discuss the new SDSU sustainable farming project called CREATE. The project is a result of a food security class Dr. Larom taught last Spring. The name of the farm might be Aztec Farm and the purpose would be to grow food and treat the land well while conserving water. This could be an CSU Extension site where there would be community and student participation.

Eric has experience in many fields including Agricultural Ecology. This site would be used as a demonstration farm as well as for education, outreach and research. Ideas for types of produce, distribution and sale of food, paybacks (beauty, groundwater recharge, wildlife, etc) were discussed. Using a pastoral system and an agriforest method would increase the diversity of the site.

Initial funding for the project would be approximately \$50,000. Dir. Long will contact our NRCS rep., Bob Hewitt, to ask for services. Shea O'Keefe, from the Escondido office, would be a good NRCS staff person to help since she is already working at SMER on various projects.

A motion was made by Dir. Rahn to have Dr. Larom send the proposal for CREATE to our Board for review. Seconded by Dir. Whitington and passed 5-0.

easement over it once it is donated so these uses need to be eliminated. Ray Johnson said these can be taken care of by the county through consent items on agendas. Dir. Rahn suggested that the RCD consider taking this parcel once the paperwork is done.

Dir. Whitington made the motion to have Dir. Rahn send the details to Ray Johnson for review.

Dir. Nelson seconded and motion approved, 5-0.

Monthly reports:

Dir. Nelson submitted a written report and added her work on a Wildlife Crossings proposal to the Resilient Habitat project of the Sierra club. She is also working with local high schools (Temecula Valley, Murrieta Mesa and Hamilton) through the Environmental Youth Program (CREEC).
