

Wine Country Water Conservation and Sustainable Farming Project

<u>Background:</u> The current 4-year California Drought is placing substantial pressure on water deliveries by the Southern California Metropolitan Water District (MWD) and the Rancho California Water District (RCWD). Urban and agriculture water users face increasing water prices.

The State of California has just ordered a mandatory 25% reduction in water use by residential users. Agricultural users have been given a "pass" in this recent emergency action.

RCWD provides retail water delivery to two separate regions within the water district. The Eastern portion covers the city of Temecula, a small portion of Murrieta, and the Temecula Wine Country. The Santa Rosa portion supplies water to the De Luz area. Water costs in the De Luz area are about twice the cost in the Eastern portion of the district.

According the recent reports by the RCWD, agricultural water users represent about 27% of total water use within the district. In the De Luz area, Citrus and Avocados the mainstay agricultural crops for years are failing. Rising water costs are rendering citrus and avocado crops unfeasible to farm because of high water needs and costs. These two crops require about 3-4 acre feet of water to be productive. Many small farmers (2-10 acres) are under irrigating, failing to properly maintain groves, and/or have just stopped irrigating altogether. Failure to maintain these groves allows for the increasing pest and disease issues that present problems for all regional growers.

The Temecula Valley has a long history of agriculture land uses. Today, the local wine industry is the only sustainable agricultural crop. Various estimates show that wine-tourism contributes over one-half billion dollars to the local economy and employs nearly 6,000 persons. More wineries will be developed in the coming years requiring more wine grapes.

In the 2000, local vineyards were devastated by Pierce's Disease. Wine grape acreage is still down by approximately 50%. Neglected citrus groves in the region provide a natural habitat for "glassy winged sharp shooters", a vector that carries Pierce's Disease, provide no economic benefit to the region, and require substantial levels of water.

A workable solution

A multi-faceted approach should be developed to reduce overall agricultural irrigation needs, lower water importation demand, lower plant disease risks, provide for better soil erosion control, and benefit the regional wine-tourism economy.

The proposed program is a demonstration project for 100 total acres and limited to properties between 2-10 acres. Water savings would be immediate.

Example:

100 acres of citrus X 3 AF = 300 acre feet per year 100 acres of vines X 1 AF = 100 acre feet per year

Savings: 200 acre feet per year

Using RCWD's water importing costs at \$900/AF for MWD water, the immediate cost savings to the district is \$180,000 per year.

Program Concept:

- 1. Remove non-productive Citrus Groves by providing small growers an incentive of \$20 per tree to remove and mulch them. The grants would be payable upon installation of vines.
- 2. Trees would be chipped into mulch for use on farming sites and road frontage for storm runoff erosion control.
- 3. Work with the MWD's conservation program to assist growers with replacement grants to plant wine-grapes.
- 4. Negotiate favorable pricing with private sector vineyard suppliers (i.e. Nurseries, trellis, irrigation vendors) to lower overall vineyard installation costs.

Program Benefits:

- 1. Reduce water use and MWD importation costs and basin salts/solids.
- 2. Improve storm water runoff.
- 3. Reduce pest and disease risks.
- 4. Provide for sustainable farming.
- 5. Increase grape production for wine-tourism industry sustainability.
